CONSOLIDATION ORDER 2003 AMENDMENT ORDER (NO1) 2005

Swindon Borough Council (hereinafter referred to as "the Council") in exercise of its powers under Section 35(1) and (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act, 1984, (hereinafter referred to as "the 1984 Act") as amended and the Road Traffic Act 1991 (hereinafter referred to as "the 1991 Act") and of all other enabling powers and after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

1 CITATION

This Order shall come into operation on the 15 April 2005 and may be cited as The Borough of Swindon (Fee Paying Off-Street Parking Places) Consolidation Order 2003 Amendment Order (No 1) 2005.

2 INTERPRETATION

"Disabled person's vehicle' has the same meaning as in the Local Authorities Traffic Orders (Exemptions from Disabled Person's) (England and Wales) Regulations 2000.

"Disabled Persons Badge" means a badge issued by the Local Authority in accordance with the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000.

"Parking Place" means an area of land specified by name in Schedules 2 to 9 of the 2003 Order and provided by the Council pursuant to Section 32(1) of the 1984 Act for the purpose of the vehicle parking and not closed (in part or in whole) by a Notice erected thereon by authority of the Council.

"Parking Bay" means a part of the parking place marked out for the leaving of a vehicle

3 AMENDMENT

The Borough of Swindon (Fee Paying Off-Street Parking Places) Consolidation Order 2003 (hereinafter referred to as "the 2003 Order") shall be further amended as follow:

Delete Article 22 Disabled Persons' Vehicle from the 2003 Order and substitute with:

Disabled Persons' Vehicles

- (1) The driver of a vehicle left in accordance with the provisions of the 2003 Order in a parking place, shown in Schedules 2 to 6 and 8 and 9 of the 2003 Order shall be exempt from purchasing a parking ticket if the vehicle is a disabled person's vehicle or a vehicle which displays a Disabled Badge provided at the time that the vehicle was left in the parking bay it was being driven or used by the person or institution to whom the badge was issued.
- (2) The restrictions imposed by Article 10 of the 2003 Order shall not apply to vehicles displaying a Disabled Person's Badge in the parking places in paragraph (1) of this Article.
