CONSOLIDATION ORDER 2003 AMENDMENT ORDER (NO2) 2005

Swindon Borough Council (hereinafter referred to as "the Council") in exercise of its powers under Section 35(1) and (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act, 1984, (hereinafter referred to as "the 1984 Act") as amended and the Road Traffic Act 1991 (hereinafter referred to as "the 1991 Act") and of all other enabling powers and after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

- 1. This Order shall come into operation on the 3 August 2005 and may be cited as The Borough of Swindon (Fee Paying Off-Street Parking Places) Consolidation Order 2003 Amendment Order (No 2) 2005.
- 2. The Borough of Swindon (Fee Paying Off-Street Parking Places) Consolidation Order 2003 ("the Consolidation Order" is hereby varied as follows:-
 - (a) After the definition of "Shopmobility Scheme" in Article 2 of the Consolidation Order insert the following definition:

"Staff Parking Permit" means a parking permit issued by Swindon and Marlborough NHS Trust in accordance with the Swindon and Marlborough NHS Trust Healthy Travel Plan in respect of a vehicle belonging to a member of staff at the Great Western Hospital, Swindon ("the Hospital") or anyone whose work is based at the Hospital on permanent or temporary employment.

After Article 18 of the Consolidation Order there shall be inserted:

18A USE OF STAFF PARKING PERMITS AT THE GREAT WESTERN HOSPITAL, SWINDON

- (i) A member of staff at the Great Western Hospital or anyone whose work is based at the Hospital may make an application for a Staff Parking Permit which is judged by the criteria for the Swindon and Marlborough NHS Trust Healthy Travel Plan.
- (ii) A member of staff at the Great Western Hospital or anyone whose work is based at the Hospital who has either been refused a Staff Parking Permit or does not hold a valid Staff Parking Permit must park their vehicle in that part of the parking place which is designated for visitors and shall purchase and display a valid parking ticket in accordance with Article 17 and 18.
- (iii) Vehicles displaying a valid Staff Parking Permit are allowed to be parked in all of the car parks at the Great Western Hospital site with the exception of the West car park, the Accident and Emergency car park and only in special designated areas for staff parking in the North Car Park and Treatment Centre Car Park.
- (iv) No person shall cause or permit a vehicle to be left in any part of the parking place at the Hospital designated for staff parking unless a valid Staff Parking Permit has been displayed.

- Mannagagun Any person who has been issued with a Staff Parking Permit must comply with the (v) instructions for its use issued with the Staff Parking Permit. This includes where a weekly or daily Staff Parking Permit has been issued, the correct date, day of the week and month of the year much be shown to coincide with the first day it is used and a parking ticket for the correct amount must be purchased unless the fee has Open Marie Marin San
- The Staff Parking Permit and any parking ticket, which has been purchased in (vi) accordance with instructions, for its use must be displayed conspicuously inside the vehicle in the relevant position in order that they can be read from outside the
- No person shall cause or permit a vehicle displaying a Staff Parking Permit to (vii) remain in any part of the parking place at the Hospital when the Staff Parking Permit has expired.
