SWINDON BOROUGH COUNCIL (FEE PAYING OFF-STREET PARKING PLACES) CONSOLIDATION ORDER 2003 AMENDMENT ORDER No. 1 2006

NOTICE IS HEREBY GIVEN that on the 8 February 2006 Swindon Borough Council made the above Order under the provisions of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991, as follow: -

To amend The Borough of Swindon (Fee Paying Off-Street Parking Places) Consolidation Order 2003 the effect of which will be:-

- 1. To create a new Town Centre Parking Zone that will enable those residents within that zone to purchase a Resident's Season Ticket to park in long stay car parks with the exception of Spring Gardens, Carlton Multi-Storey and Brunel North Multi Storey Car park.
- 2. To allow the holders of a residents parking permit in residents parking Zones A, B, C, D, E, F, G, H, J, K, L and N on purchasing an overnight car park ticket in a car park adjoining their zone, that would normally be valid from 6 pm to 6 am to park for an additional 3 hours to 9 am, for no additional payment subject to the residents' parking permit and car park ticket being displayed on the vehicle.

The proposed Order will further enforce the above Consolidation Order (which provides for decriminalised enforcement of fee paying off street parking places).

The Order will be operative as of 3 April 2006 and a copy of the sealed Order may be inspected at Customer Services, Wat Tyler House, Euclid Street, Swindon between 9.00 am and 4.30 pm Monday to Friday.

If you wish to question the validity of the Order, or of any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirements of that Act or of any instrument made thereunder has not been complied with in relation to the Order, you may, within 6 weeks from 8 February 2006 apply to the High Court for this purpose.

Swindon Borough Council (hereinafter referred to as "the Council") in exercise of its powers under Section 35(1) and (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the 1984 Act") as amended and the Road Traffic Act 1991 (hereinafter referred to as "the 1991 Act") and of all other enabling powers and after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

1 CITATION

This Order shall come into operation on the 3 April 2006 and may be cited as The Borough of Swindon (Fee Paying Off-Street Parking Places) Consolidation Order 2003 Amendment Order (No 1) 2006.

The Borough of Swindon (Fee paying off-street parking places) Consolidation Order 2003 ("hereafter referred to as the 2003 Order") shall be further amended as follows:

Insert in Article 2 of the 2003 Order the following definitions:

"Town Centre Resident" means a person whose usual place of abode is at premises the postal address of which is in a road or part of a road within the marked area identified as a Town centre parking zone shown in Schedule 10(a).

"resident's season ticket" means a ticket purchased from the Council, by a Town Centre Resident subject to certain conditions, valid for the period specified on the ticket for use in the parking places specified on the ticket.

Resident's parking permit means a permit which has been issued by the Council to a person whose usual place of abode is at premises the postal address of which is in a road or part of a road within those areas designated by the Council as residents' parking zones A, B, C, D, E, F, G, H, J, K, L and N

Delete Article 4(ii) of the 2003 Order and substitute with:

4(ii) The parking places specified in the said Schedules 2 to 9 shall be in operation at all times with the exception of Spring Gardens, Carlton multi-storey and Brunel North multi-storey car parks which are closed overnight at periods from time to time agreed by the Council.

Insert after Article 17, Article 17A

The holder of a resident's parking permit in residents parking zones A, B, C, D, E, F, G, H, J, K, L and N on purchasing an overnight car park ticket in a car park adjoining their zone, that would normally be valid from 6.00 pm to 6.00 am may park for an additional 3 hours to 9.00 am, for no additional payment subject to the resident's

parking permit and car park ticket being displayed on the vehicle in accordance with Article 18 (ii) and (iii). The issue of a resident's parking permit shall not imply any reservation of parking space.

Insert after Article 24, Article 24A


- 24A (i) The Council may sell to the owner of a vehicle who is a Town Centre Resident a Resident's season ticket in respect of a vehicle to be parked in a parking bay in any town centre long stay car park listed in Schedule 5 at the charges specified in Schedule 11 and that Resident's season ticket when displayed in the vehicle in accordance with Article 18(ii) and (iii) shall be valid only for the parking place or parts of parking place shown on it. The issue of a resident's season ticket shall not imply any reservation of parking space.
 - (ii) Article 24 (iv) and (v) shall apply to residents' season tickets.
 - (iii) An application for a residents' season ticket for the parking of that vehicle in a parking place listed in schedule 5 shall be made on a form issued by and obtainable from the Council or authorised agent and shall include the particulars and information required by such form to be supplied and such fee as is for the time being prescribed by the Council.
 - (iv) The Council or authorised agent may at any time require an applicant for a resident's season ticket or a holder of the said ticket to produce to an officer of the Council or authorised agent such evidence in respect of an application for a resident's season ticket as they may reasonably require to verify the particulars or information given to them or to verify that the resident's season ticket is valid.
