**(WAITING RESTRICTIONS, STREET PARKING PLACES, CLEARWAYS AND BUS STOP**  
**CLEARWAYS) CONSOLIDATION ORDER 2003**  
**AMENDMENT ORDER (NO.11) 2006**

Swindon Borough Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3), 4(2), 19, 32, 35, 45, 46, 47, 49, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), as amended and the Road Traffic Act 1991 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and with the Road Traffic Act 1991, hereby make the following Order:-

1. This Order shall come into operation on the 4<sup>th</sup> April 2007 and may be cited as the Swindon Borough Council (Permitted Parking Area and Special Parking Area) (Waiting Restrictions, Street Parking Places, Clearways and Bus Stop Clearways) Consolidation Order 2003 Amendment Order (No.11) 2006.
2. The Swindon Borough Council (Permitted Parking Area and Special Parking Area) (Waiting Restrictions, Street Parking Places, Clearways and Bus Stop Clearways) Consolidation Order 2003 ("the Consolidation Order") is hereby further amended as follows:-
