Swindon Borough Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 9, 19, 32, 35, 45, 46, 47, 49, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), as amended and the Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and with the Traffic Management Act 2004, hereby make the following Order:-

PART I CITATION AND INTERPRETATION

- This Order shall come into operation on the 1st September 2008 and be continued until the 28 February 2010 may be cited as the Swindon Borough Council (Permitted Parking Area and Special Parking Area) (Waiting Restrictions, Street Parking Places, Clearways and Bus Stop Clearways) Consolidation Order 2003 Experimental Order (No.1) 2008.
- For the purposes of this Order under the Traffic Management Act 2004 'Permitted Parking Area and Special Parking Area' shall be replaced by 'Special Enforcement Areas and Civil Enforcement Areas' and 'Parking Attendants' shall be replaced by 'Civil Enforcement Officers'.
- Under Section 10(2) of the Road Traffic Regulation Act 1984, the Interim Director of Highways or any other person authorised by him may modify or suspend the operation of this Order or any provision of it if it appears to him essential:-
 - (a) in the interest of the expeditious, convenient and safe movement of traffic
 - (b) in the interest of providing suitable and adequate on-street parking facilities or
 - (c) for preserving or improving the amenities of the area through which any road affected by this Order runs.

This power shall be exercised only after consulting of the appropriate Chief Officer of Police and giving such public notice as the Secretary of State may direct.

- 4. The Swindon Borough Council (Permitted Parking Area and Special Parking Area) (Waiting Restrictions, Street Parking Places, Clearways and Bus Stop Clearways) Consolidation Order 2003 ("the Consolidation Order") is hereby experimentally by the making of this Order further amended as follow:-
 - (a) By the revision of the following sheets attached to the Consolidation Order of 2003:
