Swindon Borough Council (hereafter referred to as "the Council") in exercise of its power under Section 35(1) and 3 and Part IV of Schedule 9 of the Road Traffic Regulation Act, 1984, (hereinafter referred to as "the 1984 Act") as amended and The Traffic Management Act 2004 (hereinafter referred to as "the 2004 Act") and of all other enabling powers and after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

1. This Order shall come into operation on the 19th day of January 2009 and may be cited as The Borough of Swindon (Fee Paying Off Street Parking Places) Consolidation Order 2003 Amendment Order (No. 2) 2008
2. For the purposes of this Order under the Traffic Management Act 2004 'Permitted Parking Area' and 'Special Parking Area' shall be replaced by 'Special Enforcement Areas and Civil Enforcement Areas' and 'Parking Attendants' shall be replaced by 'Civil Enforcement Officers'. All reference to the Road Traffic Act 1991 is replaced by provisions contained in part 6 of the 2004 Act.
3. The Borough of Swindon (Fee Paying Off-Street Parking Places) Consolidation Order 2003 ("the Consolidation Order") is hereby varied as follows:-

After schedule 9 in the 2003 Order a new schedule 9A is to be added.

The 2003 is amended to include schedule 9A in articles 1 to 35.

After Article 10 (ii) of the Consolidation Order there shall be inserted

- 10 (iii) The maximum period of waiting in Oasis car park as specified in Schedule 9A shall be 5 hours.


After Article 18A of the Consolidation Order there shall be inserted

18B USE OF PARKING PERMITS AT THE OASIS

- (i) Any person who has been issued with a parking permit from Oasis must comply with the instructions for its use and must be displayed conspicuously inside the vehicle in the relevant position in order that they can be read from the outside of the vehicle.
