- For the purposes of this Order under the Traffic Management Act 2004 'Permitted Parking Area 2. and Special Parking Area' shall be replaced by 'Special Enforcement Areas and Civil Enforcement Areas' and 'Parking Attendants' shall be replaced by 'Civil Enforcement Officers'.
- The Swindon Borough Council (Permitted Parking Area and Special Parking Area) (Waiting Restrictions, Street Parking Places, Clearways and Bus Stop Clearways) Consolidation Order 2003 ("the Consolidation Order") is hereby varied as follows:-
