## **AMENDMENT ORDER (NO.11) 2009**

Swindon Borough Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3), 4(2), 19, 32, 35, 45, 46, 47, 49, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), as amended and the Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and with the Traffic Management Act 2004, hereby make the following Order:-

# PART I CITATION AND INTERPRETATION

- 1. This Order shall come into operation on the 13<sup>th</sup> July 2009 and may be cited as the Swindon Borough Council (Permitted Parking Area and Special Parking Area) (Waiting Restrictions, Street Parking Places, Clearways and Bus Stop Clearways) Consolidation Order 2003 Amendment Order (No.11) 2009.
- 2. For the purposes of this Order under the Traffic Management Act 2004 'Permitted Parking Area and Special Parking Area' shall be replaced by 'Special Enforcement Areas and Civil Enforcement Areas' and 'Parking Attendants' shall be replaced by 'Civil Enforcement Officers'.
- 3. The Swindon Borough Council (Permitted Parking Area and Special Parking Area) (Waiting Restrictions, Street Parking Places, Clearways and Bus Stop Clearways) Consolidation Order 2003 ("the Consolidation Order") is hereby varied as follows:-
