CONSOLIDATION ORDER 2003 AMENDMENT ORDER (No.1) 2010

Swindon Borough Council (hereinafter referred to as "the Council") in exercise of its powers under Section 35(1) and (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the 1984 Act") as amended and the Traffic Management Act 2004 (hereinafter referred to as "the 2004 Act") and of all other enabling powers and after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

1 CITATION

This Order shall come into operation on the 13 September 2010 and may be cited as The Borough of Swindon (Fee Paying Off-Street Parking Places) Consolidation Order 2003 Amendment Order (No 1) 2010.

- 2** The Borough of Swindon (Fee paying off-street parking places) Consolidation Order 2003 ("hereafter referred to as the 2003 Order") and any amendment Orders made thereafter shall be further amended as follow:

Insert in Article 2 **INTERPRETATION** of the 2003 Order the following definitions:

"parking attendant" to be superseded with:

"civil enforcement officer" has the meaning given in section 76 of the Traffic Management Act 2004.

The meaning of "Penalty Charge" to be superseded with:

"penalty charge" has the same meaning assigned to it by the Civil Enforcement of Parking Contraventions 2007 and the amount prescribed by the Council and at the higher and lower level rate as specified in the Civil Enforcement of Parking Contraventions (Guidelines on Level of Charges) General Regulations 2007

The meaning of "Penalty Charge Notice" to be superseded with.

"penalty charge notice" means a notice issued by a Civil Enforcement in accordance with Regulation 9 and 10 of the Civil Enforcement of Parking Contraventions (England) General Regulations 2007

Delete Article 18 from the 2003 Order and Insert a new Article 18 "PAY AND DISPLAY CAR PARK"

18. A parking ticket used in a parking place shown in Schedules 2 to 6 and 8 to 9 shall only be a valid:

- (i) If it has been purchased from a ticket machine by the insertion of legal tender of appropriate value or credit card making up the amount of the charge for which payment is being made;
- (ii) If it is exhibited on the vehicle in a relevant position;
- (iii) the ticket or tickets is/are exhibited on the vehicle so that the time of purchase, the time by which the vehicle must depart, the fee paid and any other information shown on the front of the ticket or tickets are clearly visible; and
- (iv) For the period purchased for parking displayed on the ticket and a vehicle shall not be left in the parking place for longer than the period permitted by the said ticket.


