

**SWINDON BOROUGH COUNCIL**  
**(WAITING AND LOADING RESTRICTIONS AND PARKING PLACES**  
**CONSOLIDATION) ORDER 2010 (VARIATION NO. 5) ORDER 2010**

Swindon Borough Council in exercise of the powers conferred by Sections 1(1), 2(1) to (3), 4(2), 19, 32, 35, 45, 46, 47 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984), as amended and the Traffic Management Act 2004 ("the Act of 2004") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:-

- 1 The Order shall come into operation on the 23<sup>rd</sup> day of May 2011 and may be cited as the "Swindon Borough Council (Waiting and Loading Restrictions and Parking Places Consolidation) Order 2010 (Variation No. 5) Order 2010".
- 2 The Swindon Borough Council (Waiting and Loading Restrictions and Parking Places Consolidation) Order 2010 is hereby varied as follows:
  - A) The following plans marked tile reference "CG24 sheet revision number 0 shall be revised to sheet revision number 1 and CG25 sheet revision number 0 shall be revised to sheet revision number 1".
  - B) The effect of the Order is to introduce "No Waiting At Any Time" restriction Cartwright Drive, Roughmoor Way and Sandacre Road.
  - C) Any preceding revisions of the said plans are revoked and substituted with the plans attached to this Order.
