Swindon Borough Council in exercise of the powers conferred by Sections 1(1), 2(1) to (3), 4(2), 19, 32, 35, 45, 46, 47 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984), as amended and the Traffic Management Act 2004 ("the Act of 2004") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:-

- 1 The Order shall come into operation on the 12th day of December 2011 and may be cited as the "Swindon Borough Council (Waiting and Loading Restrictions and Parking Places Consolidation) Order 2011(Variation No. 10) Order 2011".
- 2 The Swindon Borough Council (Waiting and Loading Restrictions and Parking Places Consolidation) Order 2011 is hereby varied as follows:

A) The following plans marked tile reference

"CE33sheet revision number 0 shall be revised to sheet revision number 1"

B) The effect of the Order is to revoke 'No Waiting at Any Time' restrictions on

Argyle Street – South side

i) From the eastern property boundary of number 84 Argyle Street for a distance of 22m in an easterly direction

ii) From a point 252m east of its junction with Cricklade Road for a distance of 18m in an easterly direction (outside properties 86, 92, 94, and 96 Argyle Street)

and to introduce 'No Waiting at Any Time' restrictions along:

Argyle Street – South side

iii) from the eastern property boundary of number 84 for a distance of 16m in an easterly direction.

C) Any preceding revisions of the said plans are revoked and substituted with the plans attached to this Order.
