

**SWINDON BOROUGH COUNCIL (VARIOUS ROADS, OLD TOWN)
(TEMPORARY PROHIBITION OF DRIVING AND WAITING) ORDER 2013**

Whereas Swindon Borough Council ("the Council") being the Traffic Authority is satisfied that users of the roads specified in the Schedules to this Order should be restricted on the grounds of health and safety and to facilitate the safe movement of traffic attending the Swindon Mela.

NOW THEREFORE the Councils in exercise of their powers under Section 14 and 15 of the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers hereby make the following Order:

1. This Order shall come into operation on Saturday 14 September 2013 and maybe cited as the Swindon Borough Council (Old Town, Swindon) (Temporary Closure and Restriction) Order 2013.
2. Save as provided in Article 8 no person shall cause or permit any vehicle to enter the roads specified in Schedule 1 to this Order between 9 am to 8 pm on 14 September 2013.
3. Save as provided in Article 8 no person shall cause or permit any vehicle to wait and load at any time on the length of roads specified in Schedule 2 to this Order between 9 am to 8 pm on 14 September 2013.
4. Save as provided in Article 8 no person shall enter or proceed in the direction as specified on the road in Schedule 3 to this Order between the hours of 9 am to 8 pm on the 14 September 2013.
5. Any contravention to the restrictions imposed by this Order specified in Schedule 2 is liable to be issued with a penalty charge notice in accordance with The Traffic Management Act 2004, s78, Civil Enforcement of Parking Contraventions (England) General Regulations 2007 and Civil Enforcement of Parking Contraventions (England) Representations and Appeals Regulation 2007.
6. For the purpose of this Order "penalty charge notice" means a notice issued or served by a Civil Enforcement Officer pursuant to the provisions of Section 78 of the Traffic Management Act 2004 and regulations made thereunder;
7. The restrictions imposed by this Order specified in Schedule 2 shall apply during such times that traffic signs in accordance with the Traffic Signs Regulations and General Directions 2002 are placed on the highway.
8. Nothing in Article 1, 2 and 3 shall apply to:
 - (i) Vehicles used for Police, Fire and Ambulance in the event of an emergency
 - (ii) Anything done with the permission of or at the direction of a police constable in uniform
 - (iii) Residents who have displayed in a relevant position a permit issued by the Swindon Mela Committee.
9. In this Order 'relevant position' means the display of the permit in the windscreen of a vehicle and the permit must be fully visible at all times

Marlborough Lane	(part only)
Westlecot Road (North side)	The length from its junction with Roman Crescent up to its junction with The North Quarries.
Westlecot Road (South Side)	The length from its junction with Belmont Crescent (opposite Roman Crescent) up to its junction with Grovelands Avenue.
