

**SWINDON BOROUGH COUNCIL**  
**THE BOROUGH OF SWINDON**  
**(NON-FEE PAYING OFF-STREET PARKING PLACES)**  
**CONSOLIDATION ORDER 2003 EXPERIMENTAL ORDER (NO. 1) 2013**

Swindon Borough Council (hereinafter referred to as "the Council") in exercise of its powers under Sections 9 and 10 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the 1984 Act") as amended and the Traffic Management Act 2004 (hereinafter referred to as "the 2004 Act") and of all other enabling powers and after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

1. This Order shall come into operation on the 1 December 2013 for a duration of 6 months and may be cited as The Borough of Swindon (Non - Fee Paying Off-Street Parking Places) Consolidation Order 2003 Experimental Order (No. 1) 2013
2. Commercial Road Car Park as specified in Schedule 4 of The Borough of Swindon (Fee Paying Off-Street Parking Places) Consolidation Order 2003 shall be suspended for the duration of this experimental Order.
3. Under Section 10(2) of the Road Traffic Regulation Act 1984, the Head of Highways and Transport or any other person authorised by him may modify or suspend the operation of this Order or any provision of it if it appears to him essential:-
  - in the interest of the expeditious, convenient and safe movement of traffic
  - in the interest of providing suitable and adequate on-street parking facilities – or
  - for preserving or improving the amenities of the area through which any road affected by this Order runs.

This power shall be exercised only after consulting of the appropriate Chief Officer of Police and giving such public notice as the Secretary of State may direct

4. The Borough of Swindon (Non-Fee Off-Street Parking Places) Consolidation Order 2003 ("hereafter referred to as the 2003 Order") and any amendment Orders made thereafter shall be further amended as follow:

(i) By the addition of a new schedule 7 to the list of Schedules as follow:

Parking Places with a maximum 1 hour waiting period (return prohibited within 3 hours)

(ii) By the addition of Commercial Road to Schedule 7 as specified in the Schedule to this Order.

### Parking Places with a maximum 1 hour waiting period (return prohibited within 3 hours)

Parking Place	Class of Vehicles	Hours of operation Of Parking Place	Period during which restriction applies
Commercial Road	Motor car, light commercial vehicle and motor cycles not exceeding 1.5 tonnes unladen weight	All days 9 am to 9pm	All days 9am to 9pm
