THE GREATER MANCHESTER COUNTY  
(VARIOUS ROADS, ASHTON-UNDER-LYNE)  
(TRAFFIC REGULATION)  
(COUNTY) ORDER 1976.

The Greater Manchester County Council in exercise of their powers under Sections 1(1) (2) and (3) and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 and of all other enabling powers and after consultation with the Chief Officer of Police for the County of Greater Manchester in accordance with Section 84C(1) of the said Act of 1967, hereby make the following Order :-

1. Save as provided in Article 3 of this Order no person shall, except when proceeding from one dual carriageway to the other, cause any vehicle to proceed in any of the dual carriageways of either of the lengths of road specified in Schedule 1 to this Order in such direction other than so as to keep the central island on the right hand or off side of the vehicle.
2. Save as provided in Article 3 of this Order no person shall, except upon the direction or with the permission of a constable in uniform or of a traffic warden, cause or permit any vehicle to proceed in any of the lengths of road specified in Column 1 of Schedule 2 to this Order in a direction other than that specified in relation to those lengths of road in Column 2 of the said Schedule.
3. Nothing in Articles 1 and 2 of this Order shall apply to the driving of any mechanical road cleansing vehicle being used in pursuance of statutory powers.
4. This Order hereby revokes those parts of the Ashton-under-Lyne (Town Centre) (One-Way Traffic) Order 1969 which prohibit two-way traffic on the lengths of road specified in Schedule 3 to this Order.
5. Save as provided in Article 7 of this Order no person shall cause any vehicle proceeding in the northerly length of Bentinck Street, Ashton-under-Lyne in the Borough of Tameside in the County of Greater Manchester to make a left-hand turn into Stamford Street.
6. Save as provided in Article 7 of this Order no person shall cause any vehicle proceeding in any of the roads specified in Column 1 of Schedule 4 to this Order to make a right-hand turn into the road specified opposite to those roads in Column 2 of the said Schedule.
7. Nothing in Articles 5 and 6 of this Order shall apply to any vehicle used for Fire Brigade purposes or to an ambulance or a vehicle in the service of a Police Force in any case being used in pursuance of statutory powers.

8. Every person causing any vehicle to proceed in an easterly direction in Hill Street, Ashton-under-Lyne in the Borough of Tameside in the County of Greater Manchester shall cause that vehicle, on reaching the junction of Hill Street with Cavendish Street, to make a left-hand turn into Cavendish Street.
9. The Borough of Ashton-under-Lyne (Various Streets) (Prescribed Routes) Order 1969 shall have effect as though the items specified in Schedule 5 to this Order were omitted.
10. The Interpretation Act 1889 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
11. This Order shall come into operation on the 1st day of February, 1977 and may be cited as the Greater Manchester County (Various Roads, Ashton-under-Lyne) (Traffic Regulation) (County) Order 1976.

SCHEDULE 1.

1. That length of Park Parade, Ashton-under-Lyne from the roundabout at Whitelands to the roundabout at Manchester Road.
2. That length of Cavendish Street, Ashton-under-Lyne from the roundabout at Park Parade to a point 10 metres south of Bank Street.
