The Greater Manchester County Council in exercise of their powers under Sections 1(1) and (2) and (3) and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 and of all other enabling powers and after consultation with the Chief Officer of Police for the County of Greater Manchester in accordance with Section 84C(1) of the said Act of 1967, hereby make the following Order:-

1. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
2. The Greater Manchester County (Stamford Street and Oldham Road, Ashton-under-Lyne) (Lane Restriction) (County) Order 1976 shall have effect as though:-
 - (a) the words "Stamford Street" wherever they appear in that Order were deleted and the words "Chester Square" were substituted therefor; and
 - (b) the words "Welbeck Street" wherever they appear in that Order were deleted and the words "Welbeck Street South" were substituted therefor.
3. This Order shall come into operation on the 10th March, 1982, and may be cited as The Greater Manchester County (Stamford Street and Oldham Road, Ashton-under-Lyne) (Lane Restriction) (County) (Amendment) Order 1982.
