THE TAMESIDE METROPOLITAN BOROUGH (VARIOUS ROADS, HYDE)
(ONE-WAY TRAFFIC) ORDER 2006


THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) and of Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

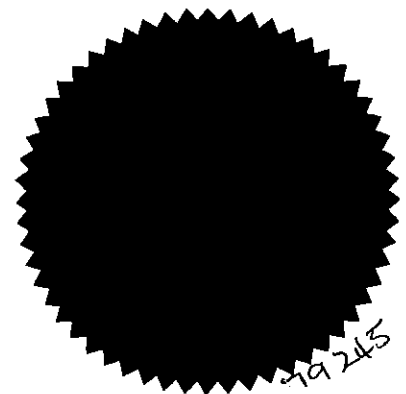
1. Save as in Article 2 and 3 of this Order, no person shall, except upon the direction or with the permission of a police constable in uniform or a traffic warden, cause or permit any vehicle to proceed in the length of road specified in Column 1 of the Schedule to this Order in a direction other than that specified in Column 2 of that Schedule.
2. Nothing in Article 1 of this Order shall apply to the driving of any mechanical road cleansing vehicle used in pursuance of statutory powers or duties.
3. Nothing in Article 1 of this Order shall apply to the driving of any vehicle being used for Ambulance, Fire Brigade or Police purposes if the observance of any provision of this Order would hinder the use of the vehicle for the purpose on which it is being used on that occasion.
4. (1) TAMESIDE METROPOLITAN BOROUGH (VARIOUS ROADS, HYDE) (ONE WAY TRAFFIC) ORDER 1992 is hereby revoked.

(2) THE TAMESIDE METROPOLITAN BOROUGH (THORNLEY STREET, HYDE) (ONE WAY TRAFFIC) ORDER 1987 is hereby revoked.
14. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by any regulations made or having effect as if made under the said Act of 1984 or by or under any other enactment.

The Order shall come into operation on the 18th day of January 2007 and may be cited as "THE TAMESIDE METROPOLITAN BOROUGH (VARIOUS ROADS, HYDE) (ONE-WAY TRAFFIC) ORDER 2006".

Column 1		Column 2
1. Church Street – between Market Street and Oldham Street	-	from its junction with Market Street to its junction with Oldham Street in a south westerly direction
2. Corporation Street – between Great Norbury Street and Jackson Street	-	from its junction with Great Norbury Street to its junction with Jackson Street in a north easterly direction
3. Edna Street – between Oldham Street and Market Street	-	from its junction with Oldham Street to its junction with Market Street in a north easterly direction
4. Edna Street – between Holme Street and Great Norbury Street	-	from its junction with Holme Street to its junction with Great Norbury Street in a south westerly direction
5. Greenfield Street – between Jackson Street and Great Norbury Street	-	from its junction with Jackson Street to its junction with Great Norbury Street in a south westerly direction
6. Henry Street – between Perrin Street and Chapel Street	-	from its junction with Perrin Street to its junction with Chapel Street in a north westerly direction
7. Henry Street – between Syddal Street and Church Street	-	from its junction with Syddal Street to its junction with Church Street in a south easterly direction
8. Higher Henry Street – between Brighton Grove and Dowson Road	-	from its junction with Brighton Grove to its junction with Dowson Road in a south easterly direction
9. Jackson Street – between Corporation Street and Greenfield Street	-	from its junction with Corporation Street to its junction with Greenfield Street in a north westerly direction
10. Thornley Street – between Dowson Street and Tower Street	-	from its junction with Dowson Street to its junction with Tower Street in a north westerly direction


