REGULATIONS) (HYDE) (REVOCATION) ORDER 2007

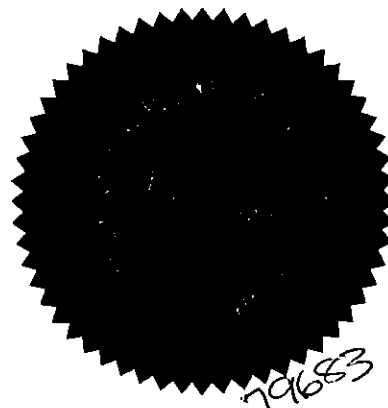
THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1) and 2(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1 THE BOROUGH OF HYDE (TOWN CENTRE SERVICE AREAS) (PROHIBITION AND RESTRICTION OF WAITING) ORDER 1973 is hereby revoked
- 2 THE BOROUGH OF HYDE (THORNLEY STREET) (RESTRICTION OF WAITING) ORDER 1973 is hereby revoked
- 3 THE BOROUGH OF HYDE (CLARENDON STREET CAR PARK SERVICE ROAD) (ONE-WAY TRAFFIC) ORDER 1971 is hereby revoked
- 4 THE BOROUGH OF HYDE (ASHTON ROAD) (PEAK HOURS) (PROHIBITION OF WAITING) ORDER, 1972 is hereby revoked.
- 5 The BOROUGH OF HYDE (RUSSELL STREET) (ONE-WAY STREET) ORDER 1964 is hereby revoked
- 6 The BOROUGH OF HYDE (NELSON STREET) (PROHIBITION OF WAITING) ORDER 1968 is hereby revoked.
- 7 The BOROUGH OF HYDE (GARDEN STREET AND HALLBOTTOM STREET) (WEIGHT RESTRICTION) ORDER 1973 is hereby revoked
- 8 The BOROUGH OF HYDE (GEORGE STREET/ HAMNETT STREET JUNCTION) (PROHIBITION OF WAITING) ORDER, 1971 is hereby revoked
- 9 This Order will come into operation on the 9th day of August 2007 and may be cited as

"THE TAMESIDE METROPOLITAN BOROUGH (VARIOUS TRAFFIC
REGULATIONS) (HYDE) (REVOCATION) ORDER 2007".


