## THE TAMESIDE METROPOLITAN BOROUGH (VARIOUS TRAFFIC REGULATION ORDERS HYDE) (AMENDMENT) ORDER 2007

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-


- 1 The TAMESIDE METROPOLITAN BOROUGH COUNCIL (HYDE TOWN CENTRE BY-PASS) (PROHIBITION OF WAITING AND LOADING AND UNLOADING ORDER 1987 shall have effect as though the restrictions on A57 Mottram Road were deleted from the Schedule.
- 2 The TAMESIDE METROPOLITAN BOROUGH COUNCIL ELIZABETH STREET, HYDE (PROHIBITION OF WAITING) ORDER 1989 shall have effect as though a Schedule were inserted into the Order prohibiting waiting at any time on the following sides and lengths of road shown on the Order plan.
  - Elizabeth Street Hyde (both sides) from its junction with Manchester Road for its whole length including the cul-de-sac end
- 3 THE GREATER MANCHESTER COUNTY (GREAT NORBURY STREET, GREENFIELD STREET AND RAILWAY STREET, HYDE) (PROHIBITION OF WAITING) (COUNTY) ORDER 1980 shall have effect as though the restrictions on Great Norbury Street were deleted from Part 1 of the Schedule
- 4 The BOROUGH OF HYDE (BEELEY STREET, PART OF REYNOLD STREET AND PART OF TRAVIS STREET) (RESTRICTION OF WAITING) ORDER 1973 shall have effect as though in the Schedule to that Order the sides of length of road Travis Street were deleted therefrom and the words "Travis Street (both sides) from a point 15 metres northwest of its junction with Union Street to its junction with Reynold Street" were substituted therefore.
- The TAMESIDE METROPOLITAN BOROUGH COUNCIL (HYDE TOWN CENTRE) (PROHIBITION AND RESTRICTION OF WAITING) ORDER 1990 shall have effect as though in Article 8 to that Order the words "Clarendon Street" were deleted therefrom and the words "Clarendon Place" substituted therefore.
- 6 The BOROUGH OF HYDE (TOWN CENTRE SERVICE AREAS)
  (PROHIBITION AND RESTRICTION OF WAITING) ORDER 1971 is hereby revoked.
- 7 The TAMESIDE METROPOLITAN BOROUGH (VARIOUS STREETS, HYDE) (PROHIBITION OF WAITING AND LOADING) (AMENDMENT No. 1) ORDER 2001 shall have effect as though in Article 2 the operative date were given as 31 December 2001

- 8 The TAMESIDE METROPOLITAN BOROUGH (ST. JOHN'S DRIVE, HYDE) (SCHOOL ENTRANCE PROHIBITION OF STOPPING) ORDER 2003 shall have effect as though in the Schedule to that Order the words "St John's Road" wherever they appear were deleted therefrom and the words "St John's Drive" substituted therefore, and in the Schedule to that Order the words "its junction with" were deleted from both descriptions of the sides and lengths of road to which the restrictions apply.
- 9 The TAMESIDE METROPOLITAN BOROUGH (VARIOUS STREETS, DENTON AND HYDE) (PROHIBITION OF WAITING AND LOADING) ORDER 2007 shall have effect as though
  - (a) in Article 6(3) the words "and 3" were deleted therefrom
  - (b) in Schedule 1 to that Order the sides of length of road Ashworth Street were deleted therefrom
  - (c) in Schedule 4 to that Order the side of length of road Queen Street (west side) were deleted therefrom

This Order shall come into operation on the 9<sup>th</sup> day of August 2007 and may be cited as

" THE TAMESIDE METROPOLITAN BOROUGH (VARIOUS TRAFFIC REGULATION ORDERS HYDE) (AMENDMENT) ORDER 2007 "
