**THE BOROUGH OF HYDE (WATER STREET) (PROHIBITION OF WAITING)
(AMENDMENT) ORDER 2007**

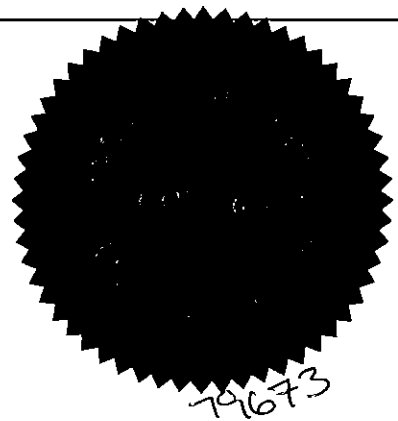
THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- (a) The BOROUGH OF HYDE (UNION STREET, WATER STREET, ONWARD STREET, CORPORATION STREET AND OLDHAM STREET) (PROHIBITION OF WAITING) ORDER 1961 shall have effect as though Schedule 1 to that Order were amended in so far as the sides and lengths of road specified in Part 1 of the Schedule to this Order were deleted therefrom and the sides and lengths of road specified in Part 2 of the Schedule to this Order were substituted therefore.
- (b) The TAMESIDE METROPOLITAN BOROUGH (VARIOUS STREETS, HYDE) (PROHIBITION OF WAITING AND LOADING) ORDER 1999 shall have effect as though in Schedule 1 the restrictions on Water Street (Northeast side) from its junction with Cross Street for a distance of 10 metres in a southeasterly direction were deleted

The Order shall come into operation on the 9th day of August 2007 and may be cited as

**"THE BOROUGH OF HYDE (WATER STREET) (PROHIBITION OF WAITING)
(AMENDMENT) ORDER 2007"**
