THE TAMESIDE METROPOLITAN BOROUGH (HALLBOTTOM STREET HYDE) (PROHIBITION OF WAITING) ORDER 2008

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. (1) In this Order:-

"authorised parking place" means any parking place on a road authorised or designated by an Order made or having effect as if made under the Act of 1984;

"disabled person's badge" has the same meaning as in the Disabled Persons (Badges For Motor Vehicles) Regulations 2000.

"disabled person's vehicle" has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England and Wales) Regulations 1986;

"parking disc" means a disc issued by a local authority, 125 millimetres square and coloured blue if issued on or after 1st. April 2001 or coloured orange if issued before that date and capable of showing the quarter hour period during which a period of waiting begins;

- (2) For the purpose of this Order a vehicle shall be regarded as displaying:-
 - (a) a disabled person's badge in the relevant position, when:-
 - (i) in the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon with the obverse side facing forwards on the near side of and immediately behind the windscreen, and
 - (ii) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the front or near side of the vehicle, and
 - (b) a parking disc in the relevant position, when the disc is exhibited thereon with the side which shows the time facing forwards or outwards and immediately behind the windscreen or side window nearest to the kerb.
- (3) except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- 2. Save as provided in Article 3 to this Order no person shall except upon the direction or with the permission of a police constable in uniform or of a civil


person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on any of the sides of lengths of roads referred to in those Articles for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same side of length of road on the same day)

- 4 The Borough of Hyde (Hallbottom Street) (Prohibition of Waiting) Order 1973 and the Borough of Hyde (Hallbottom Street) (Restriction of Waiting) (Amendment) Order 2007 are hereby revoked
- 5 The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by any regulations made or having effect as if made under the said Act of 1984 or by or under any other enactment.

The Order shall come into operation on the 10th day of April 2008 and may be cited as

"THE TAMESIDE METROPOLITAN BOROUGH (HALLBOTTOM STREET HYDE) (PROHIBITION OF WAITING) ORDER 2008".

No Waiting At Any Time.

Hallbottom Street / Garden Street (East side)

from a point 8 metres north of its junction with Sunningdale Close for a distance of 74 metres in a southerly direction.

Hallbottom Street / Garden Street (West side)

from a point 8 metres north of its junction with Sunningdale Close for a distance of 63 metres in a southerly direction

Sunningdale Close (Both sides)

from its junction with Hallbottom Street for a distance of 8 metres in a westerly direction.
