THE TAMESIDE METROPOLITAN BOROUGH (GRAFTON STREET AND BANK STREET, HYDE) (PROHIBITION OF WAITING) (AMENDMENT AND REVOCATION) ORDER 2009

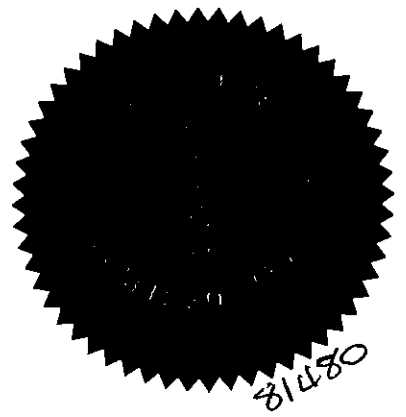
THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- (a) The TAMESIDE METROPOLITAN BOROUGH (HYDE TOWN CENTRE BY-PASS) (PROHIBITION OF WAITING AND LOADING AND UNLOADING) ORDER 1987 shall have effect as though the Schedule to that Order were amended in so far as the sides and lengths of road specified in Part 1 of the Schedule to this Order were deleted therefrom and the sides and lengths of road specified in Part 2 of the Schedule to this Order were substituted therefore.
- (b) The GREATER MANCHESTER COUNTY (ROCHFORD STREET BRIDGE, NEWTON STREET, BANK STREET, GRAFTON STREET AND KING STREET, HYDE) (PROHIBITION OF WAITING) (COUNTY) ORDER 1987 shall have effect as though Schedule 1 Part 1 to that Order were amended in so far as the sides and lengths of road Bank Street, Hyde were deleted therefrom

The Order shall come into operation on the 2nd day of July 2009 and may be cited as "THE TAMESIDE METROPOLITAN BOROUGH (GRAFTON STREET AND BANK STREET, HYDE) (PROHIBITION OF WAITING) (AMENDMENT AND REVOCATION) ORDER 2009"
