**THE GREATER MANCHESTER COUNTY (ROCHFORD STREET BRIDGE,
NEWTON STREET, BANK STREET, GRAFTON STREET AND KING STREET,
HYDE) (PROHIBITION OF WAITING) (COUNTY) (AMENDMENT) ORDER 2010**

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

The Greater Manchester County (Rochford Street Bridge, Newton Street, Bank Street, Grafton Street and King Street, Hyde) (Prohibition of Waiting) (County) Order 1976 shall have effect as though in Schedule 1 Part 2 to that Order the sides of lengths of road specified in Part 1 of the Schedule to this Order were deleted therefrom and the sides of lengths of road specified in Part 2 of the Schedule to this Order substituted therefore.

The Order shall come into operation on the 4th day of March 2010 and may be cited as

SCHEDULE

Part 1 (Deletion)

Grafton Street Hyde both sides from Pitt Street in an easterly direction to King Street

Part 2 (Substitution)

Pitt Street Hyde (north side) from its junction with King Street for a distance of 27 metres in an westerly direction

Pitt Street Hyde (north side) from a point 56 metres west of its junction with King Street for a distance of 30 metres in a westerly direction

Pitt Street Hyde (south side) from its junction with King Street for a distance of 86 metres in a westerly direction including the whole of the turning head approximately 52 metres west of King Street


