~~THE TAMESIDE METROPOLITAN BOROUGH COUNCIL~~ in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

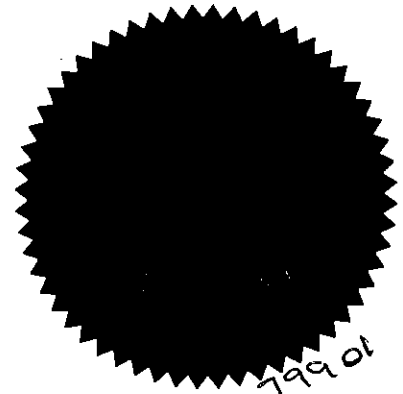
- 1 The TAMESIDE METROPOLITAN BOROUGH COUNCIL (A6018 BACK MOOR, MOTTRAM, A57 WOOLLEY LANE, HOLLINGWORTH, A628 TRUNK ROAD, HOLLINGWORTH SIDE ROADS) (PROHIBITION OF WAITING, LOADING AND UNLOADING) ORDER 1989 shall have effect as though the citation were amended to include the full title of the Order
- 2 The GREATER MANCHESTER COUNTY (WOOLLEY LANE, CROSS STREET, LORD STREET AND EARNSHAW STREET HOLLINGWORTH) (PROHIBITION OF WAITING) (COUNTY) ORDER 1980 shall have effect as though the Schedule to that Order were amended in so far as the sides and lengths of road specified in Part 1 of the Schedule to this Order were deleted therefrom and the sides and lengths of road specified in Part 2 of the Schedule to this Order were substituted therefore.
- 3 The TAMESIDE METROPOLITAN BOROUGH COUNCIL (MOTTRAM ROAD (A57), LONGDENDALE) (RESTRICTION OF WAITING OF GOODS VEHICLES) ORDER 2006 shall have effect as though the Schedule to that Order were amended in so far as the sides and lengths of road specified in Part 3 of the Schedule to this Order were deleted therefrom and the sides and lengths of road specified in Part 4 of the Schedule to this Order were substituted therefore.

This Order shall come into operation on the 18th day of October 2007 and may be cited as

from a point 13 metres east of the westerly kerblines of Melyncourt Drive to a point 98 metres east of that point

MOTTRAM ROAD (A57)
(south side layby)

from a point 14 metres west of the projected westerly kerblines of Melyncourt Drive to a point 75 metres east of that point

Part 4 (substitution)

MOTTRAM ROAD (A57)
(north side layby)

from a point 13 metres east of the
westerly kerbline of Melyncourt Drive for
a distance of 85 metres in an easterly
direction

MOTTRAM ROAD (A57)
(south side layby)

from a point 14 metres west of the
projected westerly kerbline of Melyncourt


