THE TAMESIDE METROPOLITAN BOROUGH (VARIOUS TRAFFIC REGULATION ORDERS MOSSLEY) (AMENDMENT) ORDER 2007

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- The GREATER MANCHESTER COUNTY (MANCHESTER ROAD AND WAGGON ROAD, MOSSLEY) (PROHIBITION OF WAITING) (COUNTY) ORDER 1975 shall have effect as though in Schedule 2 Part II item (a) were amended to read "Manchester Road (west side) from its junction with Station Square / Stamford Road to a point 105 metres north of its junction with Stanhope Street".
- 2 The TAMESIDE METROPOLITAN BOROUGH (STOCKPORT ROAD, MOSSLEY) (PROHIBITION OF WAITING) ORDER 1994 shall have effect as though the Schedule to that Order were amended to read "Stockport Road (north-west side) from a point 73 metres northeast of its junction with Roughtown Road to a point 7 metres southwest of the gable end of number 203 Stockport Road ".
- The TAMESIDE METROPOLITAN BOROUGH (STANHOPE STREET, MOSSLEY) (PROHIBITION OF WAITING AND ONE WAY TRAFFIC) ORDER 1996 shall have effect as though in Schedule 1 to the Order the sides and length of road "Manchester Road (east side) from its junction with Stanhope Street for a distance of 5 metres in a northerly direction " were deleted therefrom and the sides and length of road "Manchester Road (east side) from its junction with Stanhope Street for a distance of 7 metres in a northerly direction" substituted therefore
- 4 The TAMESIDE METROPOLITAN BOROUGH (OLD BROW COURT, MOSSLEY) (PROHIBITION OF WAITING) ORDER 1996 shall have effect as though in the Schedule to that Order the sides of lengths of road specified in Part 1 of the Schedule to this Order were deleted therefrom and the sides of lengths of road specified in Part 2 of the Schedule to this Order were substituted therefore

This Order shall come into operation on the 18th day of October 2007 and may be cited as
