
- 1. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 2. The Greater Manchester County (Mottram Road/Huddersfield Road/Acres Lane, Stalybridge) (Prohibition and Restriction of Waiting) (County) Order 1991 shall have effect as though in Schedule 2 to that Order the side of length of road specified in Schedule 1 to this Order were deleted therefrom.
- 3. The Greater Manchester County (Mottram Road/Huddersfield Road/Acres Lane, Stalybridge) (Prohibition and Restriction of Waiting) (County) Order 1981 shall have effect as though in Schedule 3 to that Order the side of length of road specified in Schedule 2 to this Order were deleted therefrom.
- 4. The Greater Manchester County (Mottram Road/Huddersfield Road/Acres Lane, Stalybridge) (Prohibition and Restriction of Waiting) (County) Order 1981 shall have effect as though in Schedule 1 to that Order the side of length of road specified in Part 1 of Schedule 3 to this Order were deleted therefrom and the side and length of road specified in Part 2 of Schedule 3 to this Order were substituted therefore.
- 5. This Order shall come into operation on the **28** FEB **1992** and may be cited as the Tameside Metropolitan Borough Council (Mottram Road, Stalybridge) (Prohibition of Waiting) (Amendment) Order 1991.
