**THE TAMESIDE METROPOLITAN BOROUGH (SOUTH SERVICE ROAD TO THE
REAR OF GROSVENOR STREET, STALYBRIDGE) (PROHIBITION OF DRIVING)
(AMENDMENT No 1) ORDER 2006**

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1 The Tameside Metropolitan Borough (South Service Road to the rear of Grosvenor Street, Stalybridge) (Prohibition of Driving) Order 1999 shall have effect as though Part 2 of the Schedule to that Order were amended in so far as the sides and lengths of road specified in Part 1 of the Schedule to this Order were deleted therefrom and the sides and lengths of road specified in Part 2 of the Schedule to this Order were substituted therefore.

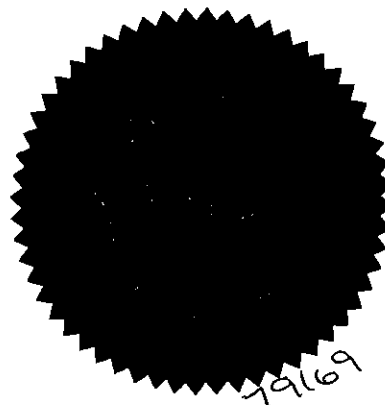
The Order shall come into operation on the 14th day of December 2006 and may be cited as

SCHEDULE

Part 1 (deletion)

South Service Road to the rear of
Grosvenor Street (North side)

From its junction with Canal Street in an
easterly direction to and including its cul-
de-sac end

(South side)

from the westerly side of Kenworthy
Street to and including its cul-de-sac end
and from a point 45 m west of Kenworthy
Street for a distance of 20 m in a westerly
direction

Part 2 (substitution)

South Service Road to the rear of
Grosvenor Street (South side)

From a point 45 metres west of its
junction with Kenworthy Street for a
distance of 20 metres in a westerly
direction

South Service Road to the rear of
Grosvenor Street (South side)

From the westerly kerbline of Kenworthy
Street to a point 7.5 metres east of the
westerly gable end of No. 37 Grosvenor
Street

South Service Road to the rear of
Grosvenor Street (South side)

From a point 35 metres east of the gable
end of No 37 Grosvenor Street in an
easterly direction up to and including its
cul-de-sac end

South Service Road to the rear of
Grosvenor Street (west cul-de-sac
end side)

From its northerly kerbline for a distance
of 5 metres in a southerly direction.

South Service Road to the rear of
Grosvenor Street (North side)

From its westerly cul-de-sac end in an
easterly direction up to and including its
easterly cul-de-sac end, including the
whole of the easterly side of the turning
head.


