(PROHIBITION OF WAITING) (AMENDMENT No. 1) ORDER 2007**

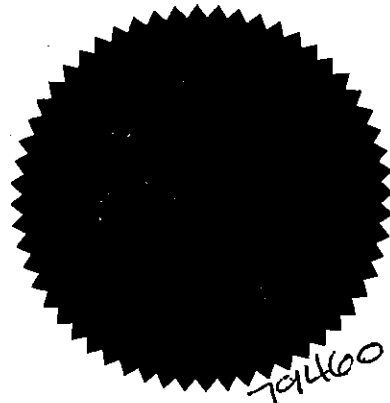
THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. **THE TAMESIDE METROPOLITAN BOROUGH COUNCIL (TAME STREET, CLARENCE STREET, STALYBRIDGE) (PROHIBITION OF WAITING) ORDER 1989** shall have effect as though:-
  - (a) In the Schedule to that Order the sides of lengths of road specified in Part 1 of the Schedule to this Order is deleted, and the sides of lengths of road specified in Part 2 of the Schedule to this Order are substituted therefore.
2. Subject to the provisions of Article 2 to this order the prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by any regulation made or having effect as if made under the said Act of 1984 or by or under any enactment.

The Order shall come into operation on the 26<sup>th</sup> April 2007 and may be cited as "**THE TAMESIDE METROPOLITAN BOROUGH (TAME STREET AND CLARENCE STREET, STALYBRIDGE) (PROHIBITION OF WAITING) (AMENDMENT No. 1) ORDER 2007**".
