**THE TAMESIDE METROPOLITAN BOROUGH (VARIOUS TRAFFIC
REGULATION ORDERS STALYBRIDGE) (AMENDMENT) ORDER 2007**

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1 The STALYBRIDGE (VARIOUS STREETS) (ONE-WAY AND PROHIBITION OF WAITING) ORDER 1966 shall have effect as though in the First and Second Schedules to that Order the restriction applying to Corporation Street were deleted.
- 2 The TAMESIDE METROPOLITAN BOROUGH COUNCIL (MOTTRAM ROAD, STALYBRIDGE) (PROHIBITION OF WAITING) (AMENDMENT) ORDER 1992 shall have effect as though in Article 2, the number "1991" were deleted and the number "1981" substituted.
- 3 The TAMESIDE METROPOLITAN BOROUGH COUNCIL (DEMESNE DRIVE / COPLEY STREET / HUDDERSFIELD ROAD, STALYBRIDGE) (PROHIBITION OF WAITING) ORDER 1992 shall have effect as though in the Schedule to that Order the words "Copley Street" wherever they appear were deleted and the words "Copley Park Mews" substituted.
- 4 THE TAMESIDE METROPOLITAN BOROUGH (CORPORATION STREET AND TRINITY STREET, STALYBRIDGE) (PROHIBITION AND RESTRICTION OF WAITING) ORDER 1994 shall have effect as though in Schedule 1 to the Order the item Trinity Street (east side) were deleted and in Schedule 2 the words "Corporation Street" were replaced by the words "Corporation Street (east side)"
- 5 THE TAMESIDE METROPOLITAN BOROUGH (DELIVERY ROAD OFF CORPORATION STREET, STALYBRIDGE) (PROHIBITION OF WAITING) ORDER 2001 shall have effect as though in the Schedule to that Order (a) the words "Service Road on the easterly side of Corporation Street some 80 metres south of Mottram Road. (both sides)" were deleted therefrom and the words "Corn Mill Lane (both sides)" were substituted therefore and (b) the sides of lengths of road "Service Area" were deleted therefrom


