ROAD TRAFFIC REGULATION ACT 1984

TAMESIDE METROPOLITAN BOROUGH COUNCIL (RIDGE HILL AREA, STALYBRIDGE) (20 MPH SPEED LIMIT) ORDER 2007

The Tameside Metropolitan Borough Council, in exercise of their powers under section 84(1)(a) and (2) of the Road-Traffic-Regulation-Act 1984, and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to that Act, hereby make the following Order:-

- No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the lengths of roads in Stalybridge specified in the Schedule to this Order.
- The TAMESIDE METROPOLITAN BOROUGH COUNCIL (BROADHILL ROAD AREA, STALYBRIDGE) (20 MPH SPEED LIMIT) ORDER 2002 is hereby revoked.
- 3. The TAMESIDE METROPOLITAN BOROUGH COUNCIL (SPRINGS LANE, STALYBRIDGE) (20MPH SPEED LIMIT) ORDER 2001 is hereby revoked.
- 4. This Order may be cited as the TAMESIDE METROPOLITAN BOROUGH COUNCIL (RIDGE HILL AREA, STALYBRIDGE) (20 MPH SPEED LIMIT) ORDER 2007, and shall come into force on 3rd July 2008.
