# THE TAMESIDE METROPOLITAN BOROUGH (WAKEFIELD ROAD, STALYBRIDGE AND MANCHESTER ROAD, MOSSLEY) (30MPH AND 40MPH SPEED LIMIT AND REVOCATION) ORDER 2010

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 82(2), 83(2), 84(1)(a) and (2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order: -

- 1. The length of road specified in Schedule 1 to this Order shall be a restricted road for the purposes of Section 81 of the Road Traffic Regulation Act 1984.
- 2 No person shall drive a motor vehicle at a speed exceeding 40mph on the length of road specified in Schedule 2 to this Order.
- 3 The Borough Council of Stalybridge (40 mph Speed Limit) (No 2) Order 1969 is hereby revoked.
- 4 The Tameside Metropolitan Borough (Manchester Road, Mossley) (40mph Speed Limit) Order 1995 is hereby revoked.

This Order will come into operation on 10<sup>th</sup> day of January 2011 and may be cited as "THE TAMESIDE METROPOLITAN BOROUGH (WAKEFIELD ROAD, STALYBRIDGE AND MANCHESTER ROAD, MOSSLEY) (30MPH AND 40MPH SPEED LIMIT AND REVOCATION) ORDER 2010".
