
- 1. The Tameside Metropolitan Borough Council (Off Street Parking Places) Order 2009 is amended as set out in Schedule 1 to this Order.
- 2. This Order shall come into force on 14 February 2014 and may be cited as the Tameside Metropolitan Borough Council (Off Street Parking Places)(Amendment)(No. 1) Order 2014.
- 3. The Interpretation Act 1978 shall apply to this Order as it applies to the interpretation of an Act of Parliament.

## **SCHEDULE 1**

1. The following rows are deleted from Schedule 1 of the Tameside Metropolitan Borough Council (Off Street Parking Places) Order 2009:

Multi-Storey (ground floor & first floor ramp)	Any motor vehicle  EXCEPT vehicles of a maximum gross weight exceeding 3500 kilograms	24 hours	Mon – Sat 8am – midnight
Multi-Storey 1 <sup>st</sup> & 2 <sup>nd</sup> floor	Any motor vehicle  EXCEPT vehicles of a maximum gross weight exceeding 3500 kilograms	10 hours on minutes Monday to Saturday	Mon – Sat 8am to 6.30 pm

- 2. The word "Multi Storey (whole car park), " listed under the Heading Hyde in Schedule 2 of the Tameside Metropolitan Borough Council (Off Street Parking Places) Order 2009 are deleted
- 3. The plan for Hyde Multi Story Car Park is removed from Schedule 4 of the of the Tameside Metropolitan Borough Council (Off Street Parking Places) Order 2009.
- 4. In Schedule 4 of the Tameside Metropolitan Borough Council (Off Street Parking Places)
  Order 2009 the plan for Beeley Street Hyde is removed and replaced by the following plan:-
