Tameside Metropolitan Borough Council (hereinafter referred to as "the Council") in exercise of its powers under section 35 of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the Chief Officer of the Police in accordance with Part III of Schedule 9 to the Road Traffic Regulation Act 1984, hereby makes the following Order:-

1. The Tameside Metropolitan Borough Council (Off Street Parking Places) Order 2009 is amended as set out in Schedule 1 to this Order.
2. This Order shall come into force on 19 November 2015 and may be cited as The Tameside Metropolitan Borough Council (Off Street Parking Places)(Amendment)(No. 3) Order 2015.
3. The Interpretation Act 1978 shall apply to this Order as it applies to the interpretation of an Act of Parliament.

SCHEDULE 1

1. In Schedule 1 of the Tameside Metropolitan Borough Council (Off Street Parking Places) Order 2009 add the following row after Church Street No. 2 (Ashton under Lyne inner Zone):-

Camp Street	Any motor vehicle EXCEPT vehicles of a maximum gross weight exceeding 3500 kilograms	3 hours Mon to Sat 8am – 6pm 24 hours at any other time	Mon – Sun 8am – midnight

2. In Schedule 2 of the Tameside Metropolitan Borough Council (Off Street Parking Places) Order 2009 add the words "Camp Street" after the words "Church Street No 2" in the row of "Ashton Under Lyne Inner Zone".
3. In Schedule 2 of the Tameside Metropolitan Borough Council (Off Street Parking Places) Order 2009 add the words "Burlington Street" after the words "Union Street" in the row of "Ashton Under Lyne Outer Zone".
4. In Schedule 4 of the Tameside Metropolitan Borough Council (Off Street Parking Places) Order 2009 add the plan – Camp Street.
5. In Schedule 4 of the Tameside Metropolitan Borough Council (Off Street Parking Places) Order 2009 replace the plan for Burlington Street with the attached plan – Burlington Street.

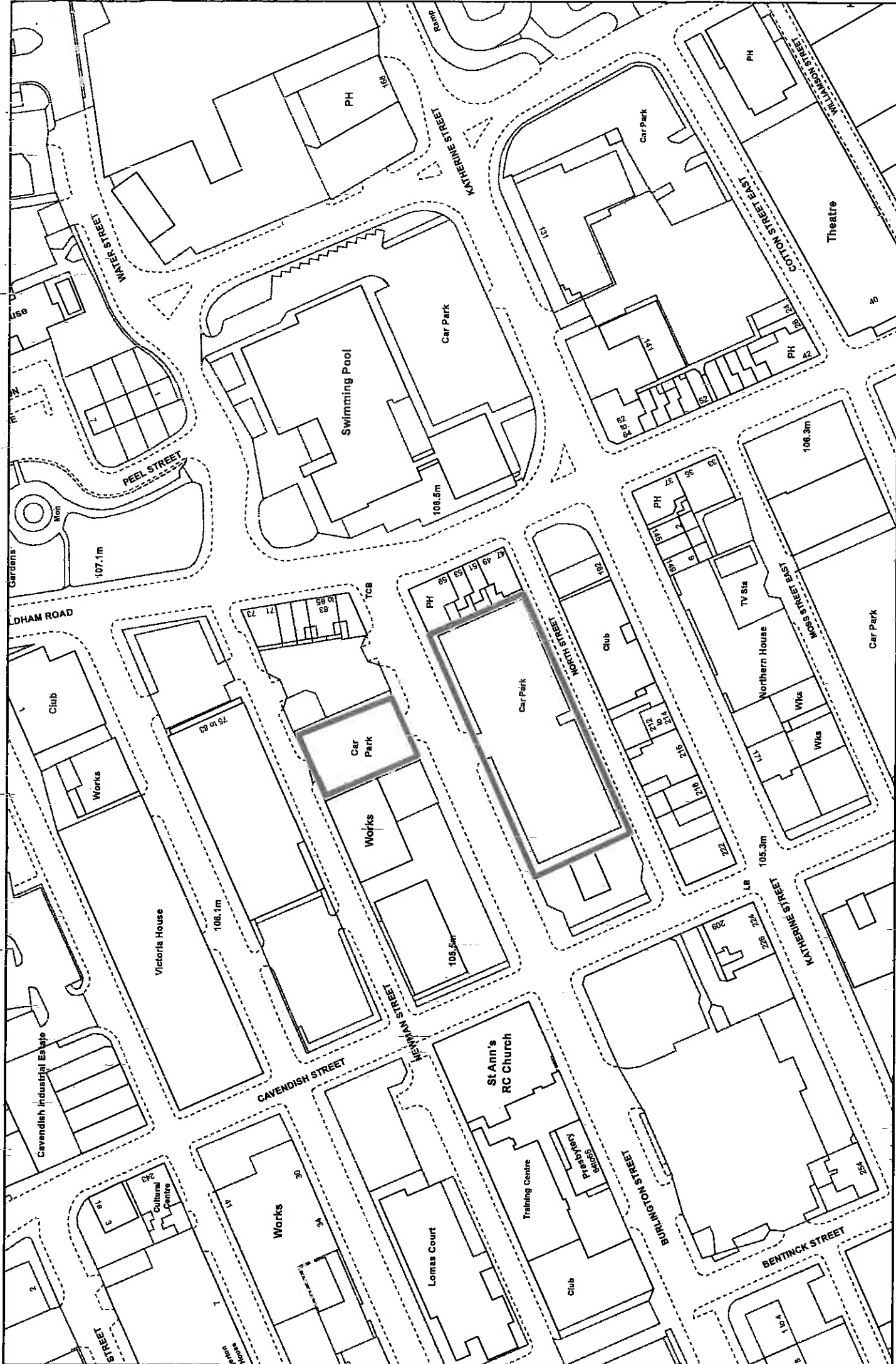
