THE TAMESIDE METROPOLITAN BOROUGH COUNCIL (OFF STREET PARKING PLACES) (AMENDMENT) (NO. 2) ORDER 2012

The Tameside Metropolitan Borough Council (hereinafter referred to as "the Council") in exercise of its powers under section 35 of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the Chief Officer of the Police in accordance with Part III of Schedule 9 to the Road Traffic Regulation Act 1984, hereby makes the following Order:-

1. The Tameside Metropolitan Borough Council (Off Street Parking Places) Order 2009 is amended as set out in Schedule 1 to this Order.
2. This Order shall come into force on the 31st day of October 2012 and may be cited as The Tameside Metropolitan Borough Council (Off Street Parking Places) (Amendment) (No. 2) Order 2012.
3. The Interpretation Act 1978 shall apply to this Order as it applies to the interpretation of an Act of Parliament.

SCHEDULE 1

1. In Schedule 1 of the Tameside Metropolitan Borough Council (Off Street Parking Places) Order 2009 insert after the row commencing Greenside Lane 2 the following:-

2. In Schedule 1 of the Tameside Metropolitan Borough Council (Off Street Parking Places) Order 2009 substitute the reference to Wimpole Street Ashton-under-Lyne to:-

Wimpole Street	Any motor vehicle EXCEPT vehicles of a maximum gross weight exceeding 3500 kilograms	24 hours	Mon-Sat 8am - midnight

3. In Schedule 1 of the Tameside Metropolitan Borough Council (Off Street Parking Places) Order 2009 substitute the reference to Rassbottom Street Stalybridge to:-

4. In Schedule 2 of the Tameside Metropolitan Borough Council (Off Street Parking Places) Order 2009 insert after to row Greenside Lane number 2 the following:-

5. In Schedule 2 of the Tameside Metropolitan Borough Council (Off Street Parking Places) Order 2009 delete the words “and Wimpole Street” from the row commencing with the words “ASHTON UNDER LYNE INNER ZONE” and insert the following row before the row commencing with the words “British Rail”:-

Until 31 December 2012 the row commencing with the words "DENTON Queen Street" in Schedule 2 of the Tameside Metropolitan Borough Council (Off Street Parking Places) Order 2009 ("the Order") shall be substituted with the following (with effect from 1 January 2013 this part of the Order will, unless a further order is made, revert to the current wording):-

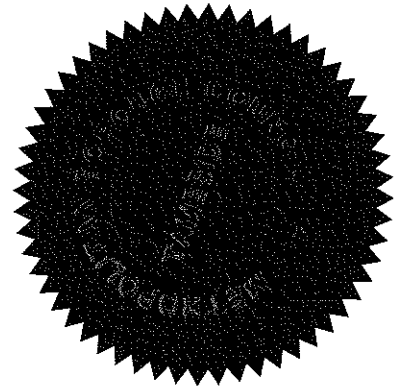

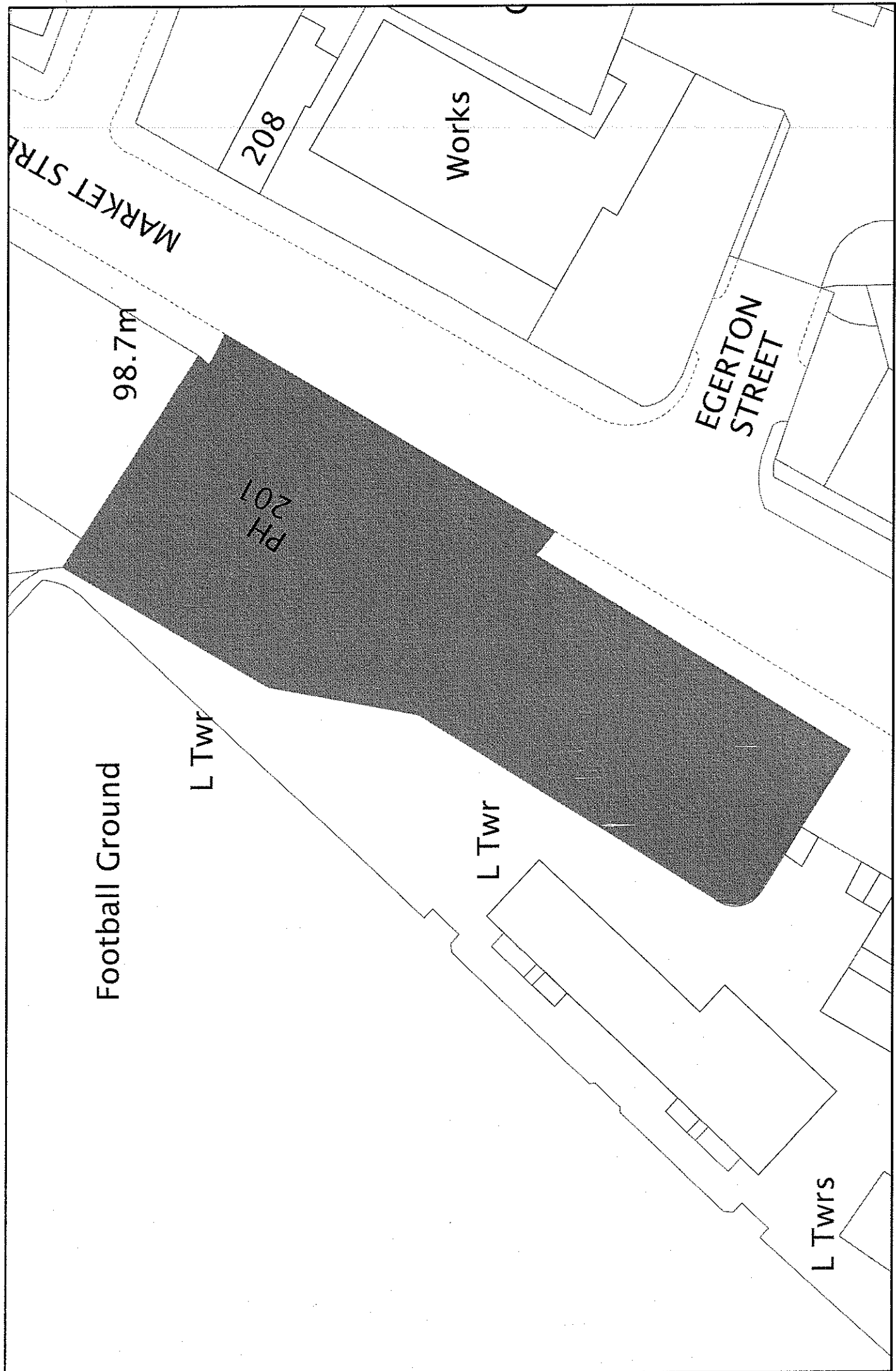
