

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL
(STAMFORD STREET, ASHTON) (ONE WAY TRAFFIC) ORDER 1992

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL - in exercise of powers under Section 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby makes the following Order :

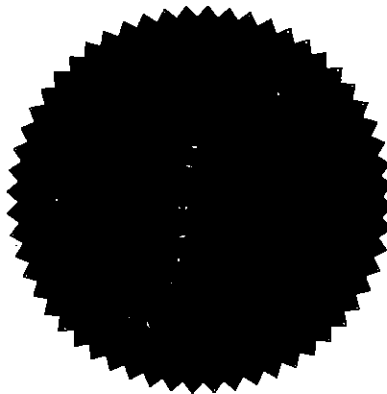
1. No person shall, except upon the direction or with the permission of a police officer in uniform or a traffic warden, cause or permit any vehicle to proceed in Stamford Street, Ashton from its junction with Scotland Street at the Telephone Exchange Roundabout (Park Parade), to its junction with Oldham Road other than in that direction.
2. Nothing in Article 1 of this Order shall apply to the driving of any mechanical road cleansing vehicle being used in pursuance of statutory powers.
3. THE BOROUGH OF ASHTON (VARIOUS ROADS) (ONE-WAY TRAFFIC) (CONSOLIDATION) ORDER 1973 shall have effect as though that length of highway in Schedule 3 of that Order specified in the Schedule 2 to this Order were deleted therefrom.
4. THE GREATER MANCHESTER COUNTY (ASHTON-UNDER-LYNE TOWN CENTRE) (RESTRICTION OF ACCESS AND TRAFFIC REGULATION) (COUNTY) ORDER 1984 shall have effect as though the lengths of highway in Schedule 2 to this Order were deleted therefrom.

The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by any regulations made or having effect as if made under the said Act of 1984 or by or under any other enactment.

The Order shall come into operation on the *22nd* day of *March*..... and may be cited as THE TAMESIDE METROPOLITAN BOROUGH COUNCIL (STAMFORD STREET, ASHTON) (ONE-WAY TRAFFIC) ORDER 1992

One-Way Traffic

**Stamford Street
Ashton**

- from its junction with Scotland Street at the Telephone Exchange Roundabout (Park Parade) to its junction with Oldham Road other than in that direction

SCHEDULE 2

**Stamford Street
Ashton**

- from its junction with the Telephone Exchange Roundabout at Park Parade to its junction with George Street from east to west
- from its junction with Delamere Street to the Oldham Road link road with Cavendish Street from east to west
