



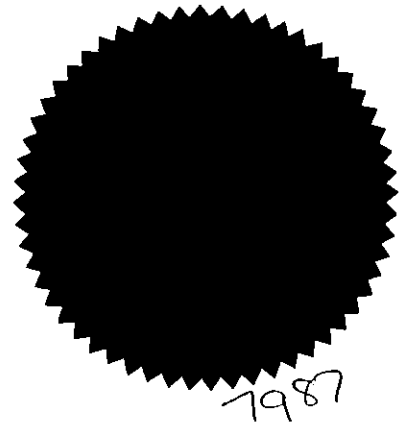
**THE TAMESIDE METROPOLITAN BOROUGH COUNCIL
(TURNER STREET AND SIDE ROADS, ASHTON-U-LYNE)
(PROHIBITION OF WAITING) (AMENDMENT No1) ORDER 1998**

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the said Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. THE TAMESIDE METROPOLITAN BOROUGH COUNCIL (TURNER STREET AND SIDE ROADS, ASHTON-U-LYNE) (PROHIBITION OF WAITING) ORDER 1989 shall have effect as though the Schedule to that Order is amended in so far as the length of road specified in Part 1 of the Schedule to this Order was deleted therefrom and the lengths of road specified in Part 2 of the Schedule to this Order substituted therefore.
2. This Order will come into operation on 7th December 1998 and may be cited as **"THE TAMESIDE METROPOLITAN BOROUGH COUNCIL (TURNER STREET AND SIDE ROADS, ASHTON-U-LYNE) (PROHIBITION OF WAITING) (AMENDMENT No1) ORDER 1998"**
