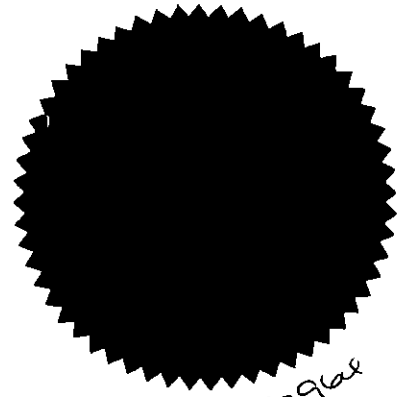
THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1) and 2(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. No person shall, except upon the direction or with the permission of a police constable in uniform or a traffic warden, cause or permit any vehicle to proceed in any of the lengths of roads specified in Column 1 of the Schedule to this Order in a direction other than that specified in relation to that length of road in Column 2 of that Schedule. (More clearly indicated on the attached plan).
2. This Order will come into operation on 17th July 2000 and may be cited as "**THE TAMESIDE METROPOLITAN BOROUGH (MARKET STREET, MARKET HALL SERVICE ROAD AND TOWN HALL SERVICE ROAD, ASHTON-UNDER-LYNE) (ONE-WAY TRAFFIC) ORDER 2000**".

Column 1

Market Street, between its junctions with Wellington Road and the Market Hall service road adjacent to the north easterly and northerly sides of the Market Hall.

Market Hall service road adjacent to the north easterly and northerly sides of the Market Hall between its junctions with Market Street and the Town Hall service road east of the Town Hall.

Town Hall service road east of the Town Hall, between its south easterly and north westerly junctions with Wellington Road.

Column 2

from Wellington Road to the Market Hall service road adjacent to the north easterly and northerly sides of the Market Hall.

from Market Street to the Town Hall service road east of the Town Hall.

from its south easterly junction with Wellington Road to its north westerly junction with Wellington Road.




