

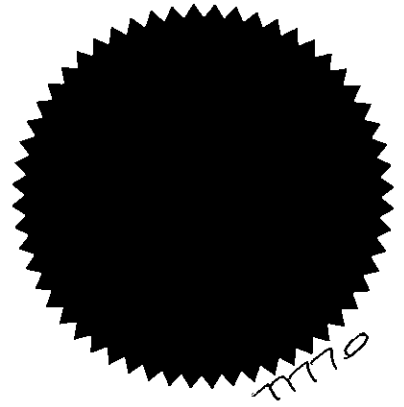
**TAMESIDE METROPOLITAN BOROUGH COUNCIL**

**GREATER MANCHESTER COUNTY**  
**(CAVENDISH STREET/OLDHAM ROAD AREA, ASHTON-U-LYNE)**  
**(PROHIBITION AND RESTRICTION OF WAITING) (COUNTY)(AMENDMENT No.3)**  
**ORDER 2005**

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. THE TAMESIDE METROPOLITAN BOROUGH (GAS STREET AND COTTON STREET EAST, ASHTON-U-LYNE)(RESTRICTION OF ACCESS AND TRAFFIC REGULATION) ORDER 1993 shall have effect as though :-  
  
Article 13 and Schedule 7 were deleted therefrom.
2. THE GREATER MANCHESTER COUNTY (CAVENDISH STREET/OLDHAM ROAD AREA, ASHTON-U-LYNE)(PROHIBITION AND RESTRICTION OF WAITING) (COUNTY) ORDER 1982 shall have effect as though:-
  - (a) In Schedule 1 to that Order the side of length of road specified in Part 1 of Schedule 1 to this Order is deleted, and the side of length of road specified in Part 2 of Schedule 1 to this Order substituted therefore.-
  - (b) In Schedule 2 to that Order the side of length of road specified in Part 1 of Schedule 2 to this Order is confirmed as deleted, and the side of length of road specified in Part 2 of Schedule 2 to this Order is inserted in Schedule 1 of that Order.
  - (c) In Schedule 1 to that Order the sides of lengths of road specified in Schedule 3 to this Order are revived
  - (d) In Schedule 2 to that Order the side of length of road specified in Schedule 4 to this Order is revived.
3. Subject to the provisions of Article 2 of this Order the restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirements imposed by any regulations made or having effect as if made under the said Act of 1984 or by or under any other enactment
4. The Order shall come into operation on the 18<sup>th</sup>. day of July 2005 and may be cited as "GREATER MANCHESTER COUNTY (CAVENDISH STREET/OLDHAM ROAD AREA, ASHTON-U-LYNE)(PROHIBITION AND RESTRICTION OF WAITING) (COUNTY)(AMENDMENT No.3) ORDER 2005"

**PART 2 (substitution)**

**MOSS STREET EAST  
(north side)**

from the junction with Cavendish Street for a distance of  
25 metres in an easterly direction.

**SCHEDULE 2.**

**(No waiting Mon-Fri, 8am-6pm)**

**PART 1 (confirmation of deletion)**

**COTTON STREET EAST  
(north side)**

from the junction with Bentinck Street for a distance of  
10 metres in an easterly direction.

**(No waiting at any time)**

**PART 2.(insertion)**

**COTTON STREET EAST  
(north side)**

from the junction with Bentinck Street for a distance of  
10 metres in an easterly direction.

### **SCHEDULE 3**

**(No waiting at any time)**

**COTTON STREET EAST**  
(north side)

from a point 5 metres west of the junction with Cavendish Street to the junction with Oldham Road.

(south side)

from a point 5 metres west of the junction with Cavendish Street to a point 15 metres east of that street.

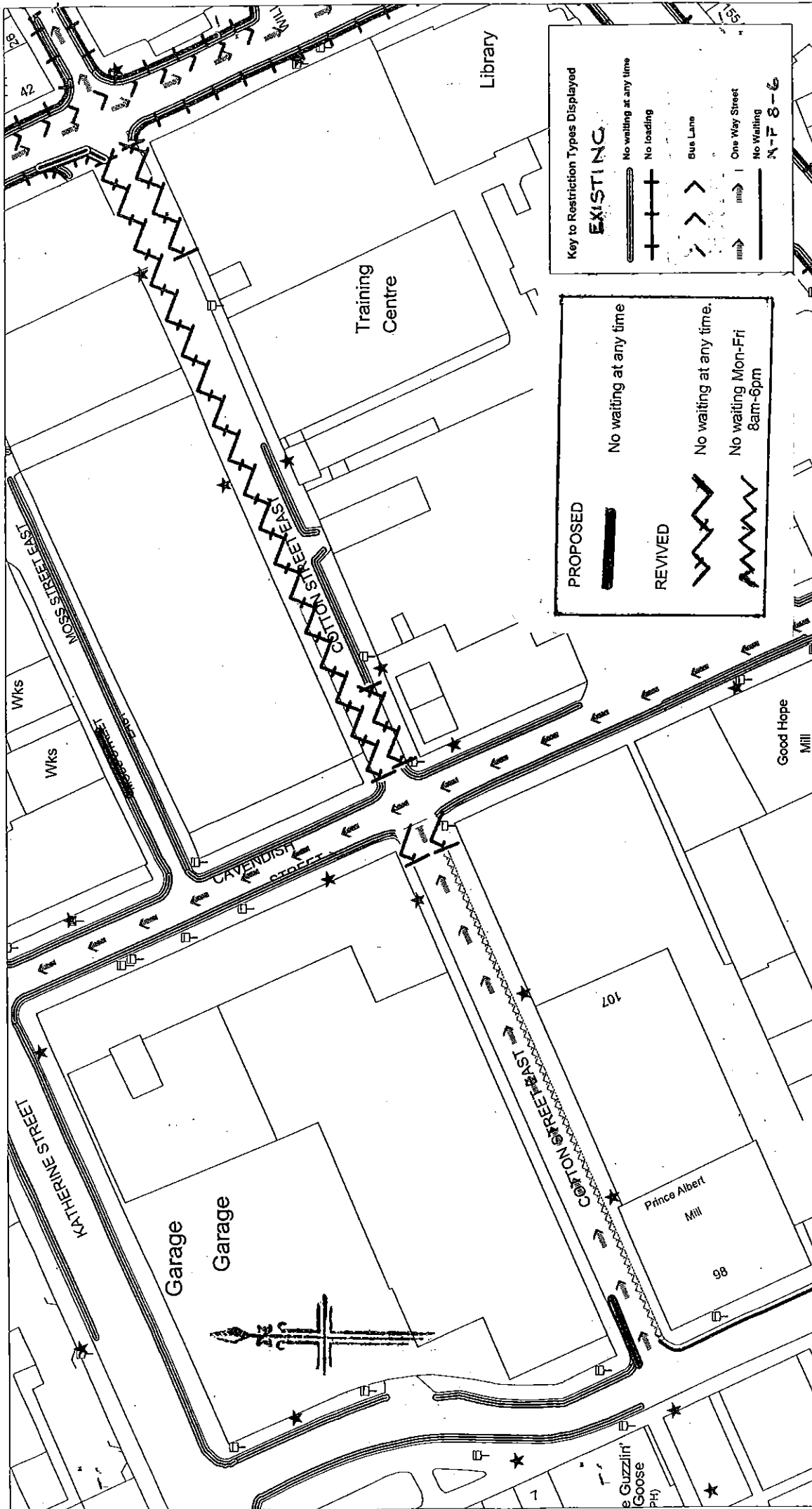
from the junction with Oldham Road for a distance of 20 metres in a westerly direction.
