THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- The Tameside Metropolitan Borough Council (Old Street and Williamson Street, Ashton under Lyne) (Restriction of Walting) Order 1992 shall have effect as though Schedule 1 to that Order is amended in so far as the sides of lengths of road specified in Part 1 of the Schedule to this Order were deleted therefrom
- The Tameside Metropolitan Borough Council (Gas Street and Cotton Street East, Ashton under Lyne) (Restriction of Access and Traffic Regulation) Order 1993 shall have effect as though
 - (a) Schedule 4 to that Order is amended in so far as the sides of length of road specified in Part 2 of the Schedule to this Order were deleted therefrom and the sides of length of road specified in Part 3 of the Schedule to this Order were inserted therein
 - (b) Schedule 5 to that Order is amended in so far as the heading were amended to read (Limited Waiting Monday Saturday 8.00am 6.00pm, 30 minutes, no return within 1 hour) and the sides of length of road specified in Part 4 of the Schedule to this Order were inserted therein

This Order shall come into operation on the 14th .day of December 2006 and may be cited as :-

"THE TAMESIDE METROPOLITAN BOROUGH (GAS STREET AND COTTON STREET EAST, ASHTON UNDER LYNE) (RESTRICTION OF ACCESS AND TRAFFIC REGULATION) (AMENDMENT) ORDER 2006"
