Part 1 (deletion)

Birch Street (Northeast side)

All that part of the northeast side of Birch Street, Ashton-under-Lyne which is bounded on the northeast by so much of the edge of the carriageway of that highway as extends from a point 30 metres southeast of Manchester Road for a distance of 75 metres in a southeasterly direction and which has a width throughout of 3 metres or thereabouts

Manor Road (South side)

All that part of the south side of Manor Road, Droylsden which is bounded on the south by so much of the edge of the carriageway of that highway as extends from a point 40 metres southwest of Sunnybank Road for a distance of 45 metres in a southwesterly direction and which has a width throughout of 3 metres or thereabouts

Edge Lane (West side)

All that part of the west side of Edge Lane, Droylsden which is bounded on the west by so much of the edge of the carriageway of that highway as extends from a point 70 metres north of Fairfield Road for a distance of 45 metres in a northerly direction and which has a width throughout of 3 metres or thereabouts
