### THE TAMESIDE METROPOLITAN BOROUGH (VARIOUS TRAFFIC REGULATION ORDERS ASHTON UNDER LYNE) (AMENDMENT) ORDER 2007

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

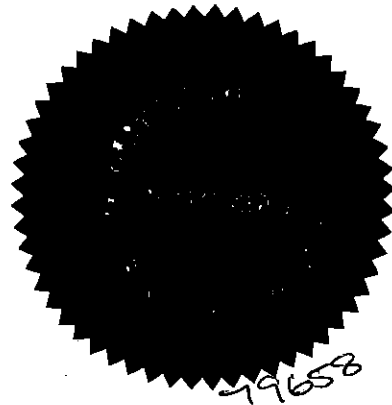
- 1 The BOROUGH OF ASHTON-UNDER-LYNE (VARIOUS STREETS - NO.1) (PROHIBITION OF WAITING) ORDER, 1973 shall have effect as though in the Schedule to that Order the references to Camp Street, Jermyn Street and Rock Street were deleted therefrom.
- 2 The TAMESIDE METROPOLITAN BOROUGH COUNCIL. (PENNY MEADOW, ALBION STREET, ASHTON-UNDER-LYNE) (PROHIBITION OF WAITING) ORDER 1992 shall have effect as though (a) Article 3 were revoked in its entirety (b) in Article 5(2) the words "the Schedule" were changed to "Schedule 1" and the words "except between the hours of 7.30am to 9.30am and 4.30pm to 6.00pm Monday to Saturday inclusive" were added after the words "at any time" (c) in Article 6 all the words after "the" in line 3 were deleted and replaced by the following words "lengths of Penny Meadow referred to in Schedule 1 of that Order are deleted".
- 3 The TAMESIDE METROPOLITAN BOROUGH COUNCIL. (CAMP STREET, HENRIETTA STREET ASHTON-UNDER-LYNE) (PROHIBITION OF WAITING AND ONE-WAY) ORDER 1992 shall have effect as though Article 6 to the Order were deleted in its entirety and replaced by the following " 6. THE BOROUGH OF ASHTON-UNDER-LYNE (VARIOUS ROADS) (CONSOLIDATION OF WAITING RESTRICTIONS) ORDER 1973 shall have the effect as though the references to Camp Street in Schedule 3 to that Order were revoked therefrom"
- 4 The TAMESIDE METROPOLITAN BOROUGH (QUEENS ROAD, ASHTON-UNDER-LYNE) (PROHIBITION AND RESTRICTION OF WAITING) ORDER 1999 shall have effect as though In Schedule 1 to the Order, item 3, the words "Claremont Terrace" were deleted and the words "Claremont Street" substituted.
- 5 The TAMESIDE METROPOLITAN BOROUGH (WELLINGTON ROAD /ROBERT SHELDON WAY (A6140), ASHTON-UNDER-LYNE) (24 HOUR CLEARWAY) ORDER 2002 shall have effect as though in the Title and Citation to the Order the word "Robert" were replaced by the word "Lord" and in Schedule 2, Part 2 of the Order the words "junction with Wellington Road" were deleted and the words "junction with Lord Sheldon Way" substituted .

The Order shall come into operation on the 26<sup>th</sup> day of July 2007 and may be cited as
