**THE TAMESIDE METROPOLITAN BOROUGH (VARIOUS STREETS, ASHTON TOWN CENTRE) (PROHIBITION AND RESTRICTION OF WAITING) ORDER 2007**

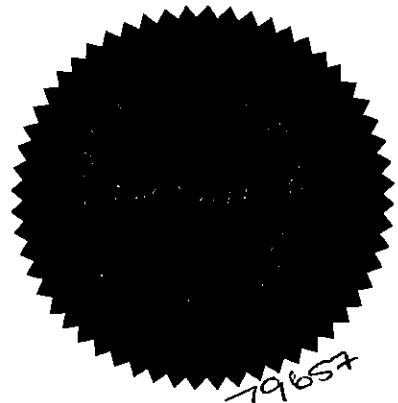
THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- (a) The Greater Manchester County (Various Streets, Ashton Town Centre) (Prohibition and Restriction of Waiting) (County) Order 1981 shall have effect as though Schedule 1 to that Order were amended in so far as the sides and lengths of road specified in Part 1 of the Schedule to this Order were deleted therefrom and the sides and lengths of road specified in Part 2 of the Schedule to this Order were substituted therefore.
- (b) The Tameside Metropolitan Borough Council. (Turner Street and Side Roads, Ashton-under-Lyne) (Prohibition of Waiting) Order 1989 shall have effect as though the Schedule to that Order were amended in so far as the sides and lengths of road specified in Part 3 of the Schedule to this Order were deleted therefrom and the sides and lengths of road specified in Part 4 of the Schedule to this Order were substituted therefore.

The Order shall come into operation on the 26<sup>th</sup> day of July 2007 and may be cited as

## **SCHEDULE**

### **Part 1 (deletion)**

Turner Lane (East side)	From Sackville Street for a distance of 85 metres in a northerly direction
West Street (East side)	from Wellington Road for a distance of 10 metres in a northerly direction
West Street (West / South sides)	from Wellington Road in a northerly and easterly direction to a point 55 metres east of Yorkshire Street

### **Part 2 (substitution)**

Turner Lane (East side)	From its junction with Sackville Street to its junction with Alexandra Road
Alexandra Road (Southeast side)	From its junction with Turner Lane for a distance of 7 metres in a northeasterly direction
Turner Street (East side)	From its junction with Wellington Road for a distance of 10 metres in a northerly direction
Turner Street (West side)	From its junction with Wellington Road to its junction with West Street
West Street (South side)	From its junction with Turner Street to a point 55 metres east of its junction with Yorkshire Street

### **Part 3 (deletion)**

Turner Street (East side)	from a point opposite the southerly kerbline of Warre Street for a distance of 85 metres in a northerly direction

### **Part 4(substitution)**

Turner Street (East side)	from a point opposite the southerly kerbline of Warre Street to its junction with Turner Lane
