**THE GREATER MANCHESTER COUNTY (A627/A6017, NORTH-SOUTH ROUTE
TAMESIDE) (PROHIBITION AND RESTRICTION OF WAITING) (NO. 1) (COUNTY)
(AMENDMENT) ORDER 2007**

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

The Greater Manchester County (A627/A6017, North-South Route Tameside) (Prohibition and Restriction of Waiting) (No. 1) (County) Order 1982 shall have effect as though

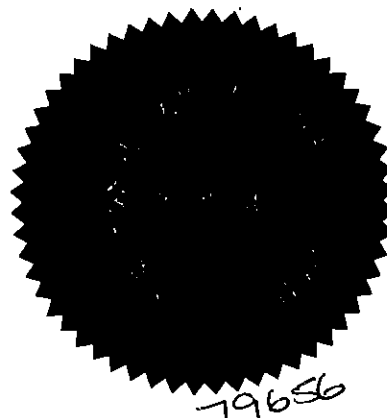
- (a) Schedule 1 to that Order were amended in so far as the sides and lengths of road specified in Part 1 of the Schedule to this Order were deleted therefrom and the sides and lengths of road specified in Part 2 of the Schedule to this Order were substituted therefore; and the word "Road" were inserted after the word "Stockport" in the second line of the restriction relating to Cambridge Street, Ashton
- (b) Schedule 3 to that Order were amended in so far as the sides and lengths of road specified in Part 3 of the Schedule to this Order were deleted therefrom; and in the eighth restriction listed under Stockport Road, Ashton the words "Williams Street" were amended to read "William Street"
- (c) Schedule 5 Part 2 to that Order were amended in so far as the sides and lengths of road specified in Part 4 of the Schedule to this Order were deleted therefrom
- (d) Schedule 6 Part 2 to that Order were amended in so far as the sides and lengths of road specified in Part 5 of the Schedule to this Order were deleted therefrom

The Order shall come into operation on the 26th day of July 2007 and may be cited as

| Audenshaw Road Audenshaw (Both sides) | from its junction with Guide Lane / Stockport Road for a distance of 50 metres west |
| Stanhope Avenue Audenshaw (Both sides) | from a point 15 metres west of its junction with Denton Road to a point 15 metres east of its junction with Denton Road |
| Victoria Street Denton (both sides) | from its junction with Stockport Road for a distance of 15 metres west |

| William Street Ashton (Both sides) | from a point 15 metres east of its junction with Stockport Road to its junction with Stockport Road |
| Stockport Road Ashton (East side) | from the northerly point of the layby at Trafalgar Square to a point 15 metres southwest of its junction with William Street |
| Audenshaw Road Audenshaw (Both sides) | from its junction with Guide Lane / Stockport Road to a point 58 metres east of its junction with St Stephen's Avenue |
| Stanhope Avenue Audenshaw (Both sides) | from its junction with Denton Road for a distance of 15 metres in a westerly direction |
| Stanhope Street Audenshaw (Both sides) | from its junction with Denton Road for a distance of 15 metres in an easterly direction |


