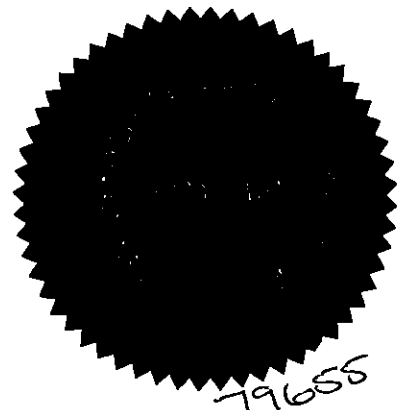

7. THE TAMESIDE METROPOLITAN BOROUGH (FOUNTAIN STREET, ASHTON-UNDER-LYNE) (BUS STOPS CLEARWAY) ORDER 2002 is hereby revoked.
8. THE ASHTON-UNDER-LYNE (WEST PARK ESTATE) (PROHIBITION OF CYCLING ON FOOTPATHS) ORDER 1967 is hereby revoked
