THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

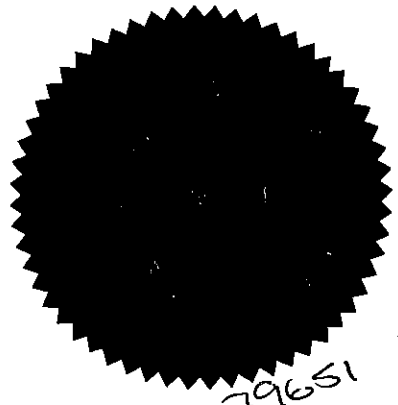
THE TAMESIDE METROPOLITAN BOROUGH COUNCIL. (WHITELANDS ASHTON) (PROHIBITION OF WAITING) ORDER 1990 shall have effect as though Schedule 1 to that Order were amended in so far as the sides and lengths of road specified in Part 1 of the Schedule to this Order were deleted therefrom and the sides and lengths of road specified in Part 2 of the Schedule to this Order were substituted therefore.

The Order shall come into operation on the 26th day of July 2007 and may be cited as

SCHEDULE

Part 1 (deletion)

Whitelands and Crescent Road (East side)	from its junction with Lower Wharf Street to a point 52 metres north of its junction with Furnace Street
Whitelands and Crescent Road (West side)	from its junction with Whitelands Road to a point 20 metres north of its junction with Riverside
Riverside (East side)	from its junction with Crescent Road for a distance of 20 metres in a northerly direction.
Riverside (West side)	from its junction with Crescent Road for a distance of 30 metres in a northerly direction.
Scotland Street (Both sides)	from its junction with the Telephone Exchange Roundabout to its junction with Whitelands.

Part 2 (substitution)

Whitelands and Crescent Road (East side)	from the junction of Whitelands with Whitelands Road to the junction of Crescent Road with Riverside
Whitelands and Crescent Road (West side)	from the junction of Whitelands with Lower Wharf Street to a point 55 metres south of the junction of Crescent Road with Furnace Street
Riverside (East side)	from the junction with Crescent Road to a point 30 metres south of the junction between the extended southeastern kerbline of Crescent Road and the extended western kerbline of Riverside
Riverside (West side)	from the junction with Crescent Road to a point 30 metres south of the junction between the extended southeastern kerbline of Crescent Road and the extended western kerbline of Riverside
Scotland Street (Both sides)	from its junction with the Telephone Exchange Roundabout (Park Parade) to the junction of Whitelands with Whitelands Road.
