The Order shall come into operation on the 26th day of July 2007 and may be cited as

Riverside (West side)

from the junction with Crescent Road to a point 30 metres south of the junction between the extended southeastern kerbline of Crescent Road and the extended western kerbline of Riverside

Scotland Street (Both sides)

from its junction with the Telephone Exchange Roundabout (Park Parade) to

the junction of Whitelands with

Whitelands Road.
