THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL. (WELLINGTON ROAD AND COWHILL LANE, ASHTON-UNDER-LYNE) (PROHIBITION OF WAITING) ORDER 1992 shall have effect as though

- (a) Article 3 to that Order were amended in so far as the sides and lengths of road specified in Part 1 of Schedule 1 to this Order were deleted therefrom and the sides and lengths of road specified in Part 2 of Schedule 1 to this Order were substituted therefore
- (b) the Schedule to that Order were amended in so far as the sides and lengths of road specified in Part 1 of Schedule 2 to this Order were deleted therefrom

The Order shall come into operation on the 26th day of July 2007 and may be cited as

"THE TAMESIDE METROPOLITAN BOROUGH COUNCIL. (WELLINGTON ROAD AND COWHILL LANE, ASHTON-UNDER-LYNE) (PROHIBITION OF WAITING)
(AMENDMENT) ORDER 2007"

21 Cowhill Lane

from a point 10 metres north of its junction with Penny Meadow to a point 25 metres north of its junction with Wimpole Street

21b Cowhill Lane (East side)

from a point 5 metres south of its junction with Wimpole Street for a distance of 42 metres in a northerly direction
