The TAMESIDE METROPOLITAN BOROUGH (VARIOUS STREETS, ASHTON-UNDER-LYNE) (PROHIBITION OF WAITING) ORDER 2001 shall have effect as though Schedule 1 to that Order were amended in so far as the sides and lengths of road specified in Part 1 of the Schedule to this Order were deleted therefrom and the sides and lengths of road specified in Part 2 of the Schedule to this Order were substituted therefore.

The Order shall come into operation on the 26th day of July 2007 and may be cited as

"THE TAMESIDE METROPOLITAN BOROUGH (VARIOUS STREETS, ASHTON-UNDER-LYNE) (PROHIBITION OF WAITING) (AMENDMENT) ORDER 2007"

Fire Service Access Area off Rudman

Street (Both sides)

its full length including its cul-de-sac end

Fire Service Access Area off Victoria Street, 50 metres northeast of Rudman Street (Both sides)

its full length including its cul-de-sac end

Fire Service Access Area off Benjamin

Street (Both sides)

its full length including its cul-de-sac end

#### Part 2 (substitution)

Rudman Street (Northeast side)

from its junction with Victoria Street for a distance of 5 metres in a northwesterly direction

Rudman Street (Northeast side)

from a point 46 metres northwest of its junction with Victoria Street to its junction with Benjamin Street

Benjamin Street (Southeast side)

from its junction with Rudman Street in a northeasterly direction up to and including its cul-de-sac end adjacent to **Balmoral Court** 

Benjamin Street (Southeast side)

from its junction with Margaret Street for a distance of 8 metres in a southwesterly direction

Benjamin Street (Northwest side)

from its southwesterly cul-de-sac end adjacent to Balmoral Court in a westerly direction to a point 65 metres northwest of the junction of Rudman Street and Victoria Street

Benjamin Street (Northeast side)

from a point 74 metres northwest of the junction of Rudman Street and Victoria Street in a northwesterly and northeasterly direction for a distance of 7 metres

Benjamin Street (Southeast side)

from a point 26 metres southwest of its junction with Margaret Street in a southwesterly direction up to and including its cul-de-sac end adjacent to

Pioneer Court

Benjamin Street (Northwest side)

from its junction with Darwin Street in a southwesterly direction up to and including its cul-de-sac end adjacent to Pioneer Court

Albert Walk (both sides)

from its junction with Victoria Street approximately 71 metres north east of Rudman Street in a northwesterly direction up to and including its cul-desac end

Victoria Street (Northwest side)

from its junction with Rudman Street for a distance of 5 metres in a northeasterly direction

Victoria Street (Northwest side)

from a point 67 metres northeast of its junction with Rudman Street for a distance of 13 metres in a northeasterly direction

Darwin Street (Southwest side)

from its junction with Benjamin Street for a distance of 4 metres in a northwesterly direction

Margaret Street (Southwest side)

from its junction with Benjamin Street for a distance of 5 metres in a southeasterly direction
