(AMENDMENT) ORDER 2007**

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

The TAMESIDE METROPOLITAN BOROUGH (OLDHAM ROAD, BETWEEN CRANBOURNE ROAD AND THE NORTHERLY JUNCTION WITH TAUNTON ROAD, ASHTON-UNDER-LYNE) (PROHIBITION OF WAITING AND LOADING) ORDER 2004 shall have effect as though

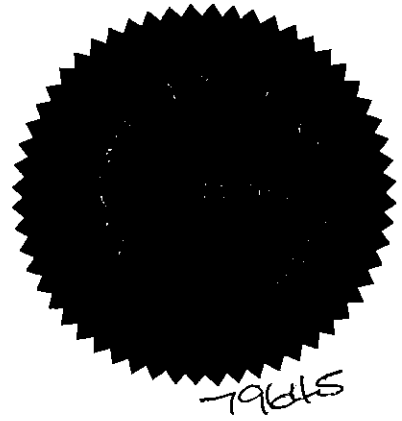
- (a) Schedule 1 to that Order were amended in so far as the sides and lengths of road specified in Part 1 of the Schedule to this Order were deleted therefrom and the sides and lengths of road specified in Part 2 of the Schedule to this Order were substituted therefore.
- (b) Schedule 2 to that Order were amended in so far as the sides and lengths of road specified in Part 3 of the Schedule to this Order were deleted therefrom and the sides and lengths of road specified in Part 4 of the Schedule to this Order were substituted therefore
- (c) Part II of Schedule 4 to that Order were amended in so far as the sides and lengths of road specified in Part 5 of the Schedule to this Order were deleted therefrom and the sides and lengths of road specified in Part 6 of the Schedule to this Order were substituted therefore

The Order shall come into operation on the 26th day of July 2007 and may be cited as

Part 5 (deletion)

Oldham Road, Ashton (West side)

from a point 90 metres north of Knowle Avenue to a point 15 metres south of Langham Street

Part 6 (substitution)

Oldham Road (West side)

from a point 90 metres north of Knowle Avenue to a point 19 metres north of Knowle Avenue


