THE TAMESIDE METROPOLITAN BOROUGH (WEST STREET AND GEORGE STREET ASHTON UNDER LYNE) (PROHIBITION OF WAITING) ORDER 2007

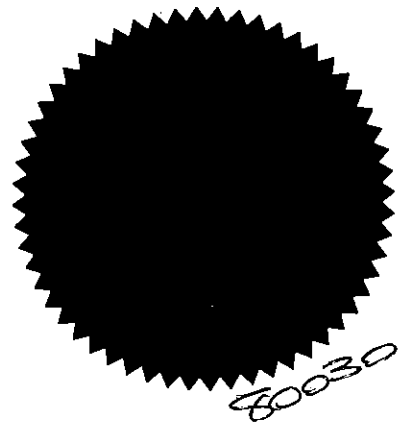
THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- (a) The Greater Manchester County (Various Streets, Ashton Town Centre) (Prohibition and Restriction of Waiting) (County) Order 1981 shall have effect as though Schedule 1 to that Order were amended in so far as the sides and lengths of road specified in Part 3 of the Schedule to this Order were deleted therefrom and the sides and lengths of road specified in Part 4 of the Schedule to this Order were substituted therefore.
- (b) The Tameside Metropolitan Borough Council. (Various Streets Ashton Town Centre) (Prohibition of Waiting) Order 2007 shall have effect as though Part 2 of the Schedule to that Order were amended in so far as the sides and lengths of road specified in Part 1 of the Schedule to this Order were deleted therefrom and Part 1 of the Schedule to that Order were amended in so far as the sides and lengths of road specified in Part 2 of the Schedule to this Order were deleted therefrom

The Order shall come into operation on the 6th day of December 2007 and may be cited as

"THE TAMESIDE METROPOLITAN BOROUGH (WEST STREET AND GEORGE STREET ASHTON UNDER LYNE) (PROHIBITION OF WAITING) ORDER 2007"

Turner Street (West side)	From its junction with Wellington Road to its junction with West Street
West Street (South side)	From its junction with Turner Street to a point 55 metres east of its junction with Yorkshire Street

Part 2

West Street (East side)	from Wellington Road for a distance of 10 metres in a northerly direction
West Street (West and South sides)	from Wellington Road in a northerly and easterly direction to a point 55 metres east of Yorkshire Street

Part 3

George Street (East side)	from Old Street to Howards Court
