STREET ASHTON UNDER LYNE) (PROHIBITION OF WAITING) (AMENDMENT)
ORDER 2008**

THE TAMESIDE METROPOLITAN BOROUGH COUNCIL in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

THE BOROUGH OF ASHTON-UNDER-LYNE (VARIOUS ROADS)
(CONSOLIDATION OF WAITING RESTRICTIONS) ORDER 1973 shall have effect as though Schedule 3 to that Order were amended in so far as the sides and lengths of road specified in Part 1 of the Schedule to this Order were deleted therefrom and the sides and lengths of road specified in Part 2 of the Schedule to this Order were substituted therefore.

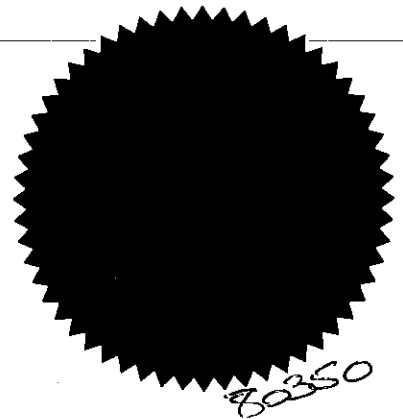
The Order shall come into operation on the 24th day of April 2008 and may be cited as

SCHEDULE

Part 1 (deletion)

32. George Street (East side)	Between its junction with Old Square and the point 1.66 yards north of its junction with Howard's Court
33. George Street (East side)	Between its junction with Old Street and the point 3.66 yards south of that junction
40. Howard's Court	The whole length

Part 2 (substitution)

32. George Street (East side)	Between its junction with Old Square and its junction with Howard Court
40A. Howard Court (North side)	From its junction with George Street for the whole length including the cul – de – sac end
40B. Howard Court (South side)	From its junction with George Street for a distance of 15 metres in an easterly direction
40C Howard Court (South side)	From a point 21 metres east of its junction with George Street in an easterly direction to the cul – de – sac end
